## RECOMMENDATION

#### BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The UStar Moon Festival was held on Friday, September 20, 2019 to Sunday, September 22, 2019 at Eastridge Mall and sponsored by Councilmember Arenas. This special event celebrated the Mid-Autumn Moon Festival, hosted an array of entertainment and cultural activities for children and their families, and delivered an important opportunity to share Vietnamese culture and tradition with the San José community. The event was free and open to the public.

#### **ANALYSIS**

In observance of existing fundraising disclosure requirements, Councilmember Arenas will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 8, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
