#### RECOMMENDATION

Accept the report and workplan to develop the Five-year Consolidated Plan, which governs the use of federal funding from the U.S. Department of Housing and Urban Development from 2020 through 2025.

# **OUTCOME**

Staff will receive input from the Neighborhood Services and Education Committee regarding the workplan for developing the City's federally-required Five-year Consolidated Plan for 2020-2025. Committee members will also provide feedback on community outreach that will occur as part of the effort to set future funding priorities under the new Consolidated Plan.

# **BACKGROUND**

The U.S. Department of Housing and Urban Development (HUD) requires jurisdictions that receive federal housing and community development grant funding to develop Consolidated Plans that identify priority needs, goals, actions, and funding strategies over five-year periods. San José receives funding from four HUD programs that are covered by the City's Consolidated Plan (see **Table 1**). This will be the City's fifth Consolidated Plan developed since 2000.

San José currently is completing approved activities under its 2015-2020 Consolidated Plan<sup>1</sup> and now is starting to develop the 2020-2025 Consolidated Plan. The deadline to submit the new Consolidated Plan to HUD is May 15, 2020.

HUD requires that each jurisdiction develop an Annual Action Plan each year to show how it will implement its Consolidated Plan. Further, the City must report back to HUD each year on how it met the goals of the prior year's Annual Action Plan. This report is called the Consolidated Annual Performance Evaluation Report, or CAPER. (Note that the CAPER covering 2018-2019 outcomes was reviewed at the Committee on September 12, 2019). City Council approval is required for the Consolidated Plan, each Annual Action Plan, and each CAPER before the documents are transmitted to HUD.

HUD reports are among the many plans and reports that the Housing Department is required to develop related to outside funding. **Attachment A** to this memorandum provides a snapshot of

these required reports. Item (d)3 on the October 10, 2019 Neighborhood Services and Education Committee agenda will discuss a related State of California-required report, the Assessment of Fair Housing Plan, which the Housing Department is developing in conjunction with the Consolidated Plan.

### **ANALYSIS**

2020-2025 Consolidated Plan Process

HUD encourages jurisdictions to complete a regional or joint Consolidated Plan, as housing, homelessness, and community issues typically cross jurisdictional boundaries. Conducting a regional analysis also may result in goals that are consistent across the region, potentially leading to better outcomes. Engaging a shared consultant provides efficiencies with time and effort spent on procurement, data analysis, and outreach. Coordinating this process across jurisdictions can be challenging. However, the effort to coordinate with other jurisdictions in past cycles has been essential to help identify regional challenges, barriers, opportunities, and shared goals and actions.

For these reasons, San José joined five other local cities, Santa Clara County, and the Santa Clara County Housing Authority to work together to develop 2015-2020 Consolidated Plans. The Santa Clara County Office of Supportive Housing, leading the collaboration, has convened a working group. The working group includes representatives from each agency, including the City's Housing Department. The working group will oversee the consultant's work. The County, on behalf of the participating jurisdictions, issued a request for proposals to select a consultant. The working group selected two consultants: one to develop the 2020-2025 Consolidated Plan and 2020-2021 Annual Action Plan, and a second to develop the regional Assessment of Fair Housing. The County Board of Supervisors approved the two selected consultants at its August 27, 2019 meeting. The County entered into contracts, and the consultants have begun their work.

For the Consolidated Plan work, the consultant will implement the regional workplan and will deliver to each jurisdiction a core set of deliverables, as well as any additional work each jurisdiction asked the consultant to produce. HUD's Participating Jurisdictions, such as San José, must produce Consolidated Plans that address local housing conditions and needs in order to meet federal Consolidated Plan requirements.

The workplan includes conducting regional community meetings and a Countywide needs survey. Additional work for San José includes the consultant providing support for meetings to be held in San José in coordination with community groups. San José will also receive its own draft Consolidated Plan and Annual Action Plan.

The public engagement for development of the Consolidated Plan's spending priorities and review of the draft Plan will include a variety of formats – stakeholder interviews, public meetings, surveys, focus groups – to solicit feedback from a broad representation of the community. The consultant-led public engagement will include three to four traditional public meetings in San José, accessible in multiple languages. The consultant will also incorporate social media (e.g. Next Door, Snapchat, Facebook, WeChat) to notify the public of meetings, distribute information, and solicit input. To reach stakeholders, the consultant will help conduct facilitated and targeted stakeholder feedback from a cross-section of the community in the form of focus groups and stakeholder interviews. Staff will also coordinate with Destination: Home to access the needs assessment being conducted as part of the development of the Countywide Community Plan to End Homelessness, so that staff can best understand current needs for homeless households and the homeless services delivery system.

To ensure that outreach in San José reaches vulnerable and hard-to-reach residents, staff will work closely with the consultant to ensure that outreach is done in multiple languages. Official public meetings will be noticed in English plus four foreign languages, with translators and accessibility equipment available. These practices will be done consistent with the City's Citizen Participation Plan for the Consolidated Plan outreach. Staff will also work with local community-based organizations to help ensure feedback is obtained from community members who may not feel comfortable taking on-line surveys, or who typically would not come to Citysponsored outreach meetings.

# **EVALUATION AND FOLLOW-UP**

Future presentations to Council Committees and to the full City Council are anticipated as outlined in the timeline in Table 2 above. Early in 2020, staff will return to Council Committees to get feedback on initial spending priorities for the new Consolidated Plan. Staff will also work with Council offices to communicate with their constituents about opportunities to give input on housing and community needs for the Consolidated Plan process.

# **COMMISSION RECOMMENDATION/INPUT**

Commissioners commented on their appreciation for fair housing work, their support for homeownership strategies, their desire for plans to include measurable goals, and their support for meaningful community engagement in creating these plans. The Commission did not vote on this item.
