SUBJECT: RETROACTIVE APPROVAL OF THE EVERGREEN COMMUNITY CENTER DIWALI CELEBRATION COMMUNITY EVENT SPONSORED BY COUNCIL DISTRICT 8 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Evergreen Community Center Diwali Celebration was held on Friday, October 18, 2019 at the Evergreen Community Center and sponsored by Councilmember Arenas. This special event celebrated Diwali, a largely celebrated holiday by the Indian-American Community, filled with fun cultural performances and lunch for seniors. The event was free and open to the public who registered.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. Approval of this memorandum will enable Council District 8, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
