#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 3 Night at Christmas in the Park event will be held on December 4, 2019 at Plaza de César E. Chávez Park and sponsored by Councilmember Raul Peralez. This special event will provide a family friendly night of live entertainment and fun activities. It will also provide the community an opportunity to look at the many decorated Christmas tress located throughout the park. The event is free and open to the public.

#### **ANALYSIS**
