SUBJECT: ELLIS ACT ORDINANCE RE-CONTROL PROVISIONS

REASON FOR SUPPLEMENTAL REPORT

The reason for this supplemental memo is to provide the recommendations made by the Housing and Community Development Commission regarding the demographic study of renters living in apartments covered by the Apartment Rent Ordinance.

ANALYSIS

The Housing and Community Development Commission held a special meeting on October 29, 2019. After hearing a staff presentation and taking comments from the public, the Housing and Community Development Commission provided recommendations to the City Council regarding the Actions Related to the Ellis Act Ordinance Re-control Provisions. The Commission wanted to highlight for City Council that one of the most significant findings in the report is that the population of ARO tenants is largely Hispanic/Latinx (47%) and that any changes to the Ellis Act Ordinance and Apartment Rent Ordinance should be thoughtful of disproportionate impact on the Hispanic/Latinx communities in addition to the impact on all communities.

The Commission also recommended that Table 9 in the Ellis Act Ordinance memo submitted to City Council for the November 5, 2019 meeting also include the numerical population for ARO renters and all renters in San José. An updated **Table 9** is included below:
