On behalf of SPUR, we are writing in full support of the staff recommendation to allocate Measure T funds to preserve land in North Coyote Valley and permanently designate it for open space and agricultural use.

SPUR has been deeply invested in San Jose for the past seven years advocating for smart growth, good government, and environmental best practices. We have watched the City make considerable progress to prioritize transit, infill development and increase economic opportunity over the last several years. Many of these accomplishments are attributed to the vision and strategy laid out in Envision 2040. Additionally, the City has adopted new policies that impact land use designations made in the general plan, such as, Climate Smart San Jose and Vehicle Miles Travel (VMT).
