I am writing to express concern regarding recent construction on a lamppost which is 30 feet away from my house and is right above a grassy area where my children play. Installation of this pole has begun and is near completion but the **HOA Association** that owns the grassy area was never notified. The lamp post is located by 1070 Polk Ln, San Jose, CA 95117.

I am aware that there is a court order for the FCC to comply to make an environmental review before installing any 5G cells and I would like to request an immediate stop to the installation on the pole until the report is received and further research is provided. As a mother of two children and part of the HOA where many kids play in that grassy area, I am a concerned community member and request an immediate halt of this project.

Subject: 5G Tower by Calboro Drive - Concerned Citizen/Homeowner

Hi,

I heard through our neighborhood meeting that a 5G cell tower was going to be installed on our corner. Please see below for my comments, and actions required:

- We did not receive a notice that a tower was going to be installed on our corner
- We are aware that there is a court orderer with the FCC to comply with the environmental review before installations
- We are REQUESTING the installations be stopped and put on hold until the FCC complies with the environmental review
- In our view of unresolved technical and health issues, we request that the city of San Jose adopt an ordinance requiring set-backs at least 300 feet from homes and 1000 feet from schools of small cell 5G equipment, and a minimum distance of 1500 feet between 5G small cell towers.
- We required that the public safety concern in the following line stated in the approved permit (quote from Verizon): "[5G cells] may exceed the FCC's occupational limit for exposure to radio frequency limits and an area that extends four feet from the antenna face that may exceed the FCC's general population limit for exposure to radio frequency emissions."

We request that you support our requests and stop the installation of 5G towers in our neighborhood and specific the corner of our property until the above have been address.

Subject: Alternative to Ground Floor Retail

I suggest that when developers want to build housing in commercial zoned areas or Urban Villages that they be allowed to substitute live/work housing for ground floor retail. These units would have a separate room for an office with a second public entrance separate from the common areas used by tenants. The tenants for those units would be required to have San Jose business licenses and be engaged in either a profession or freelance business where clients may need to visit the office (accounting, graphic design, architecture, etc.) or create art, crafts, cottage food for sale off-site, or other tangible items whose production is compatible with a residential building. There may be an exemption to the home occupation rules permitting 1-2 employees.

San Jose has very few live/work zoned areas (such as the Art Ark Apartments). Most residential leases prohibit business use, as the layout of the building makes it a security risk for other tenants. This would facilitate the growth of small businesses in San Jose.

This would make it easier to retain commercial use on the site without an empty speculative retail space.
