


UPDATE: SEXUAL ASSAULT PATTERNS AND STATISTICS (YEAR-TO-DATE)






UPDATE RE: Rape and Child Molest Categories



- From January 01, 2019 to September 30, 2019, there were 1,301 Unique Cases involving Rape or Child Molest
- 100 Cases involved more than one (1) Rape/Child Molest Offense
- Making a total of 1,401 Rape or Child Molest Offenses committed



COMPARISON AND LINEAR FORECAST 288A L&L W/ UNDER 14 YRS AND 261 RAPE







DEPARTMENT TRAINING

TRAUMA INFORMED CARE TRAINING

- Trauma Informed Team (Developed)
 - Development of curriculum (In-Process)
- Primary Goals
 - <u>Improve</u> criminal investigations, policing skills, and the leveraging of community resources through the recognition of trauma in victims
 - <u>Develop</u> cultural competency skills
 - Increase emotional wellness
 - Prevent negative impact upon mental health
- Training will be rolled out in two (2) phases:
 - <u>Phase 1:</u> Bureau of Investigations Personnel
 - <u>Phase 2</u>: Expansion Department-wide to Patrol
- Implementation early 2020





COMMUNITY TRAINING

VIGILANT PARENT INITIATIVE

- Vigilant Parent Initiative Program's pilot class launched September for the ESUHSD at Andrew Hill High School
- Outreach efforts have been made to school administrators and staff
- 2020 sessions in progress









COMMUNITY TRAINING

YWCA: SEXUAL ASSAULT EDUCATION AND TRAINING

- "TEA Club" Evidence-based program
- Funded (\$160k) by San Jose and spearheaded by YWCA
- Implemented within schools in San Jose with six (6) sessions held to date
- Objective:
 - Learn and identify the differences between healthy and unhealthy/abusive relationships
 - Develop the essentials to having a healthy relationship
- Working partnerships have been developed with:
 - San Jose Unified School District
 - Gunderson High School
 - Broadway High School
 - East Side Union High School District
 - Apollo High School
- Additional updates to come March 2020





INTERNAL IMPROVEMENTS

INTERSECTION SCREENING TOOL

- Two (2) new assessments developed and added to DV Field Report
- Domestic Violence (DV) Field Report
 - Lethality Assessment (Current)
 - Strangulation-Suffocation Assessment (Current)
 - Sexual Assault Assessment (New)
 - Human Trafficking Assessment (New)
- All four (4) assessments will provide the metrics necessary to assess intersectionality
- Implementation January 2020





INTERNAL IMPROVEMENTS

INTERNAL STATUS K: LACK OF INVESTIGATIVE RESOURCES

- Tentative two (2) new statuses:
 - 1. Lack of Victim Cooperation
 - Definition: Victim was unable to be contacted after numerous efforts made by investigator
 - 2. Victim Requested to Close Case
 - Definition: Victim stated to the investigator that they wished to close the case with the possibility to re-open it in the future
- Implementation January 2020
- Lack of Investigative Resources will be truly defined as lack of resources








LACK OF INVESTIGATIVE RESOURCES

- **Definition:** Despite Leads, a Case is Closed and Not Cleared Due to a <u>Lack of Investigative Resources</u>
- Lack of Resources Can Mean Any of the Following:
 - Seriousness of Crime
 - Lack of Staffing
 - Lack of Victim/Witness Cooperation
 - Lack of Strong Leads
 - Lack of Evidence, etc.

REPORTING "CLEARED" CASES TO FBI – UCR PROGRAM

Numbers Reported to FBI-UCR are Meant to Answer One Question:

Was a Suspect Arrested or Cited?

 If the Answer is No, the Remaining Choices are "N for Not Cleared" or "O for Exceptional Means"

What do the UCR Codes Mean?

- N The Case Was Not Cleared
- C The Case Was Cleared by Arrest or Citation
- O The Case Was Cleared by an Exceptional Circumstance Other than an Arrest or Citation (this is intended to be used sparingly)

For an Offense to be "Cleared" Within UCR (-C- or -O-), the Case Resolution Must Meet Certain Criteria (next slide):







The Criteria

Cleared by Arrest or Citation (C)

An offense is cleared by arrest, or solved for crime reporting purposes, when <u>three specific conditions</u> have been met. The three conditions are that at least one person has been:

- 1. Arrested.
- 2. Charged with the commission of the offense.
- 3. Turned over to the court for prosecution (whether following arrest, court summons, or police notice).

Cleared by Exceptional Means (O)

Elements beyond law enforcement's control prevent the agency from arresting and formally charging the offender. The following <u>four conditions</u> must be met in order to clear an offense by exceptional means.

- 1. Identified the offender
- 2. Gathered enough evidence to support an arrest, make a charge, and turn over the offender to the court for prosecution.
- 3. Identified the offender's exact location so that the suspect could be taken into custody immediately.
- 4. Encountered a circumstance outside the control of law enforcement that prohibits the agency from arresting, charging, and prosecuting the offender.

Examples of Exceptional Clearance

- Death of the offender
- Victim refuses to cooperate in the prosecution
- Offender is prosecuted by state or local authorities in another city for a different offense or is prosecuted in another city or state by the federal government for an offense which may be the same
- Extradition denied/In Custody of Other Jurisdiction. The suspect is in the custody of another jurisdiction, usually for a more serious offense, and the extradition was either denied or not pursued

Uniform Crime Reporting Statistics: Their Proper Use

Since 1930, participating local, county, state, tribal, and federal law enforcement agencies have voluntarily provided the nation with a reliable set of crime statistics through the Uniform Crime Reporting (UCR) Program. The FBI, which administers the program, periodically releases the crime statistics to the public.

Usefulness of UCR Data

UCR crime statistics are used in many ways and serve many purposes. They provide law enforcement with data for use in budget formulation, planning, resource allocation, assessment of police operations, etc., to help address the crime problem at various levels. Chambers of commerce and tourism agencies examine these data to see how they impact the particular geographic jurylicitions they represent. Criminal justice researchers study the nature, cause, and movement of crime over time. Legislators draft anti-crime measures using the research findings and recommendations of law enforcement administrators, planners, as well as public aprivate entities concerned with crime problems. The news media use the crime statistics provided by the UCR Program to inform the public about the state of crime as it compares to the national level.

Pitfalls of Ranking

UCR data are sometimes used to compile rankings of individual jurisdictions and institutions of higher learning. These incompiete analyses have often created misleading perceptions which adversely affect geographic entities and their eraidents. For this reason, her FBI has a longstanding policy against ranking participating law enforcement agencies on the basis of crime data alone. Despite repeated warnings against these practices, some data users continue to challenge and misunderstand this position.

Data users should not rank locales because there are many factors that cause the nature and type of crime to vary from place to place. UCR statistics include only jurisdictional population figures along with reported crime, clearance, or arrest data. Rankings ginore the uniqueness of each locale. Some factors that are known to affect the volume and type of crime occurring from place to place are:

- Population density and degree of urbanization.
- Variations in composition of the population, particularly we concentration
- Stability of the population with respect to residence mobility, commuting patterns, and transient factors.
- Economic conditions, including the sam income, poverty level, and job availability
 Modes of transportable or nighway systems.
- Cultural factorial and religious characteristics
- End tions with respect to divorce and family cohesiveness.

Climate.

- Effective strength of law enforcement agencies.
- Administrative and investigative emphases on law enforcement.
 Policies of other components of the criminal justice system (i.e., prosecutorial, judicial,
 - correctional, and probational). Citizens' attitudes toward crime.
- Crime reporting practices of the citizenry.

Ranking agencies based solely on UCR data has serious implications. For example, if a user wants to measure the effectiveness of a law enforcement agency, these measurements are not available. As a subsitute, a user might list UCR clearance rates, rank them by agency, and attempt to infer the effectiveness of individual law enforcement agencies. This inference is flawed because all the other measures of police effectiveness were ignored. The nature of the offenses that were cleared must be considered as those cleared may not have been the most serious, like murdler or rape. The agency's clearances may or may not result in conviction, the ultimate goal. The agency may make many arrests for Part II offenses, like drug abuse violations, which demonstrate police activity but are not considered in the clearance rate. The agency's available resources are also critical to successful operation, so its rate of officers to population and budget should be considered. The UCR clearance rate was simply not designed picture of an agency's effectiveness, data users must consider an agency's emphases and resources; and its crime, clearance, and arrest rates; along with other appropriate factors.
