**SUBJECT: APPROVE TRASH TALKS SPONSORED BY COUNCIL DISTRICT 6 AS CITY COUNCIL SPONSORED SPECIAL EVENTS TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENTS**

## RECOMMENDATION

1. Retroactively approve the Trash Talks held on August 23, 2019, September 27, 2019 and October 11, 2019, and approve the Trash Talk scheduled on November 8, 2019 as City Council sponsored Special Events and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the November 19, 2019 Council Agenda for action.

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Trash Talks were held on August 23, 2019 at 1335 S. Bascom Avenue, on September 27, 2019 at 1432 W. San Carlos Street, #70, and on October 11, 2019 at 806 W. Home Street. A future Trash Talk will be held on November 8, 2019 at 601 Bird Avenue. These special events are sponsored by Councilmember Dev Davis and provide an opportunity for residents to chat with Councilmember Dev Davis and her team while helping clean-up the streets of District 6. The events were free and open to the public.

## ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure

requirements, Councilmember Dev Davis will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 6, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
