The Evergreen Leadership Neighborhood Association Winter Community Event will be held on Saturday, December 14, 2019 at Ida Jew Academy and sponsored by Councilmember Arenas. This special event will feature games, crafts, and all kinds of family-friendly activities. The event is free and open to the public.

# ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Arenas will report any cash or in-kind donations received for the
