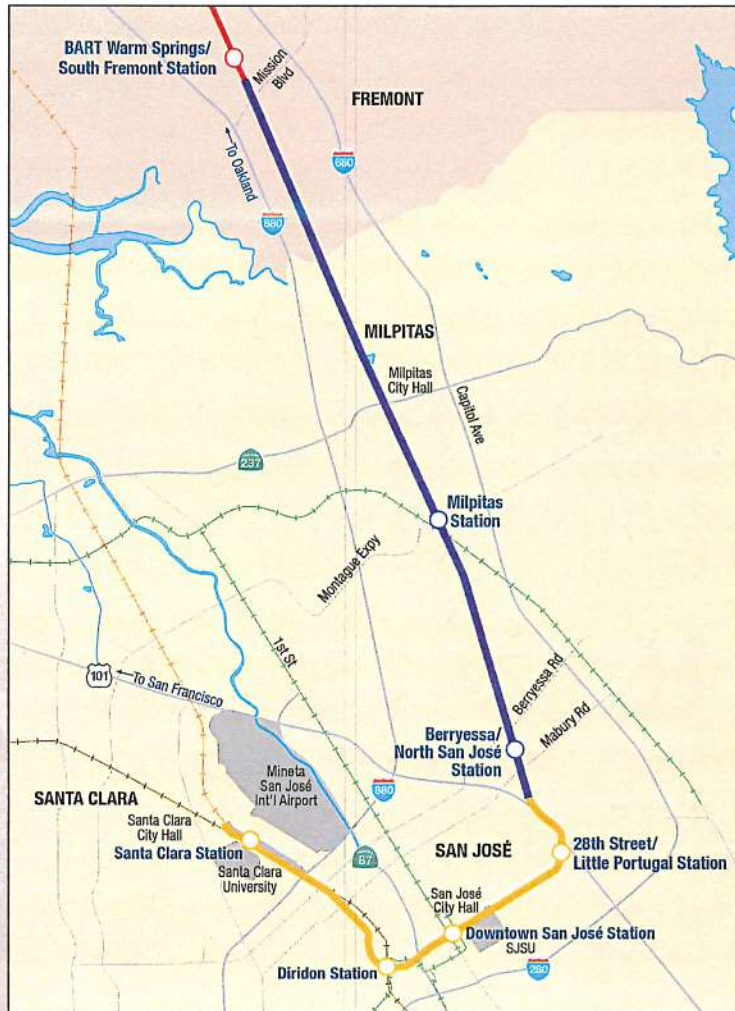

## Phase I Extension

- 10-mile extension
- Undergoing train testing
- 2 stations
  - Milpitas
  - Berryessa/North San Jose

## Phase II Extension

- 6-mile extension (5-mile tunnel)
- 4 stations
  - Little Portugal/28<sup>th</sup> Street
  - Downtown San Jose
  - Diridon
  - Santa Clara
- Newhall Yard Maintenance Facility



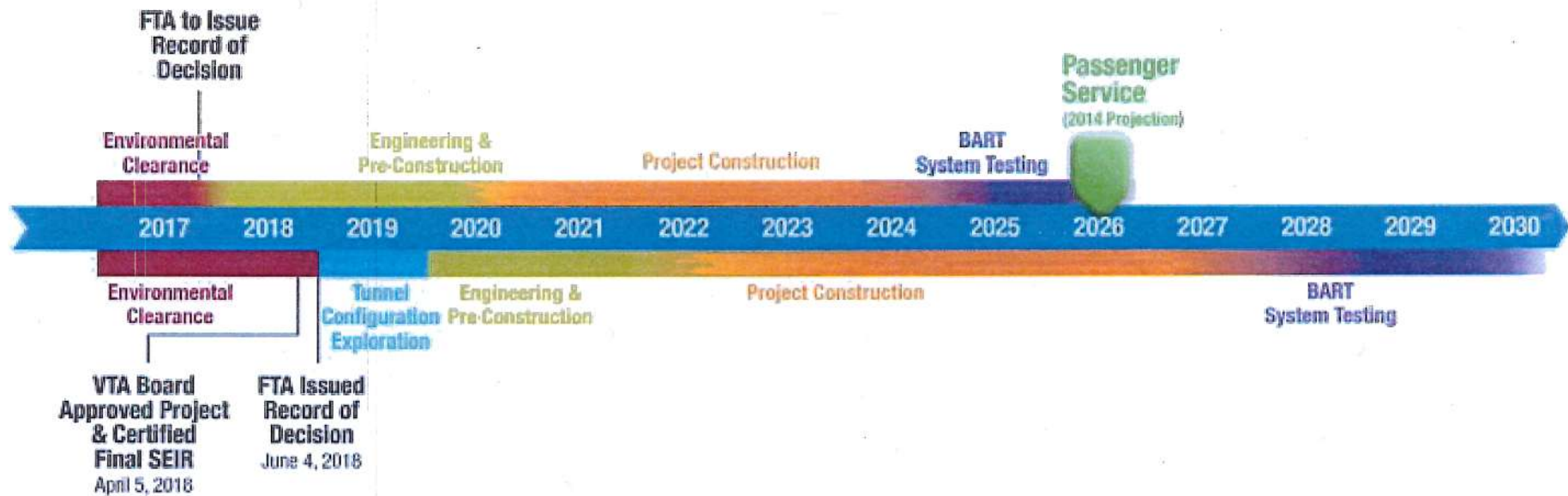

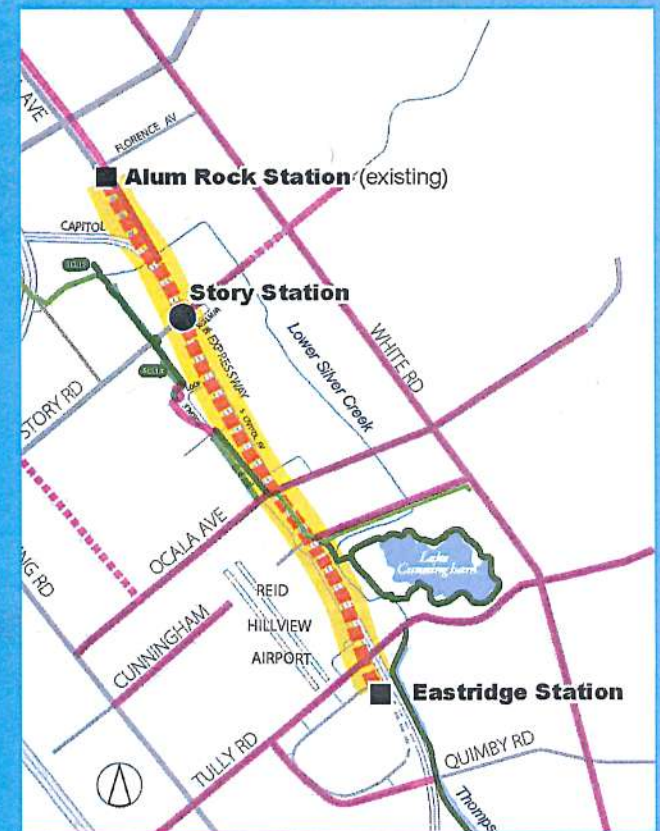
### Next Steps

# Eastridge to BART Regional Connector

- 2.4 Miles Light Rail Extension from Alum Rock station to Eastridge
- Final engineering underway with completion fall 2020
- Property acquisition underway
- Utility relocation agreements being finalized
- Start in Early 2021

## Upcoming Activities

- Implementation of the Community Working Group
- Presentation and coordination of the construction impact mitigation plans with focus on noise, vibration, and traffic mitigation.
- Initiation of artwork implementation with City lead. Begin with agreement approval and solicitation of artists.

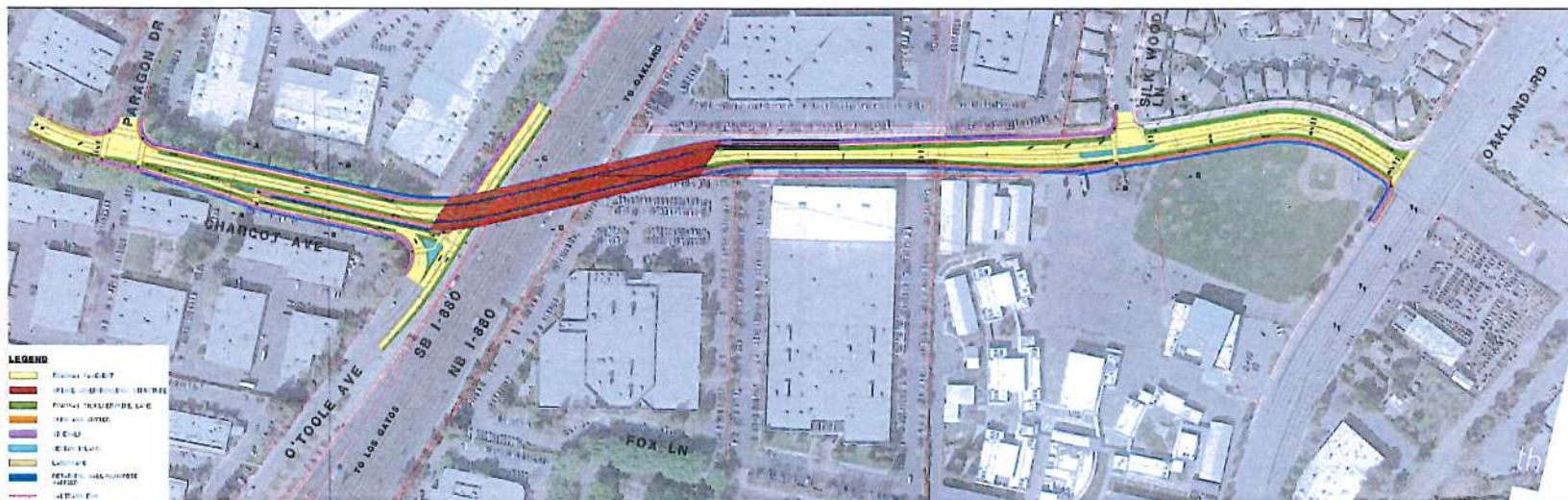


# U.S. 101/De la Cruz Blvd Trimble Road Interchange

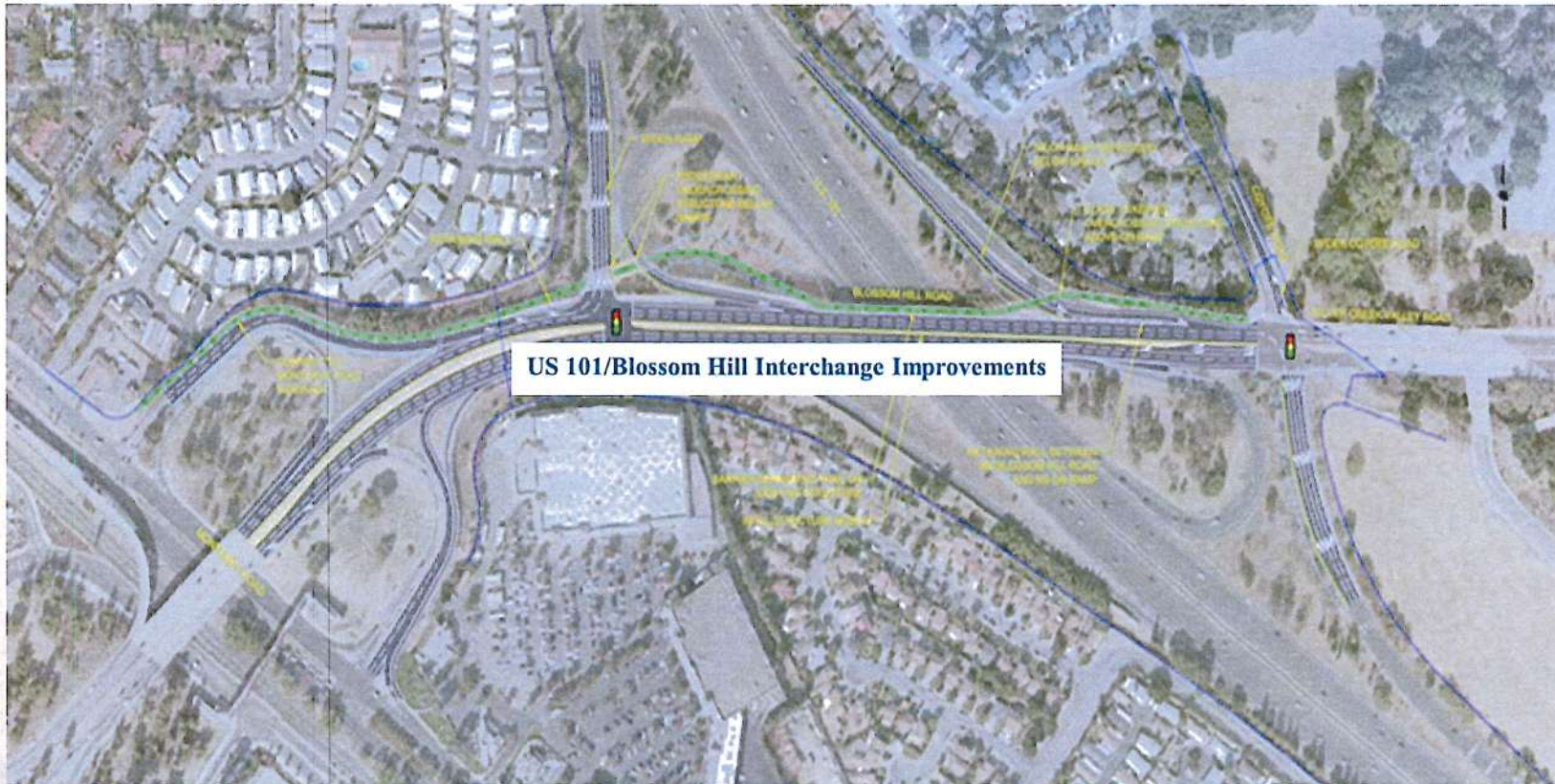

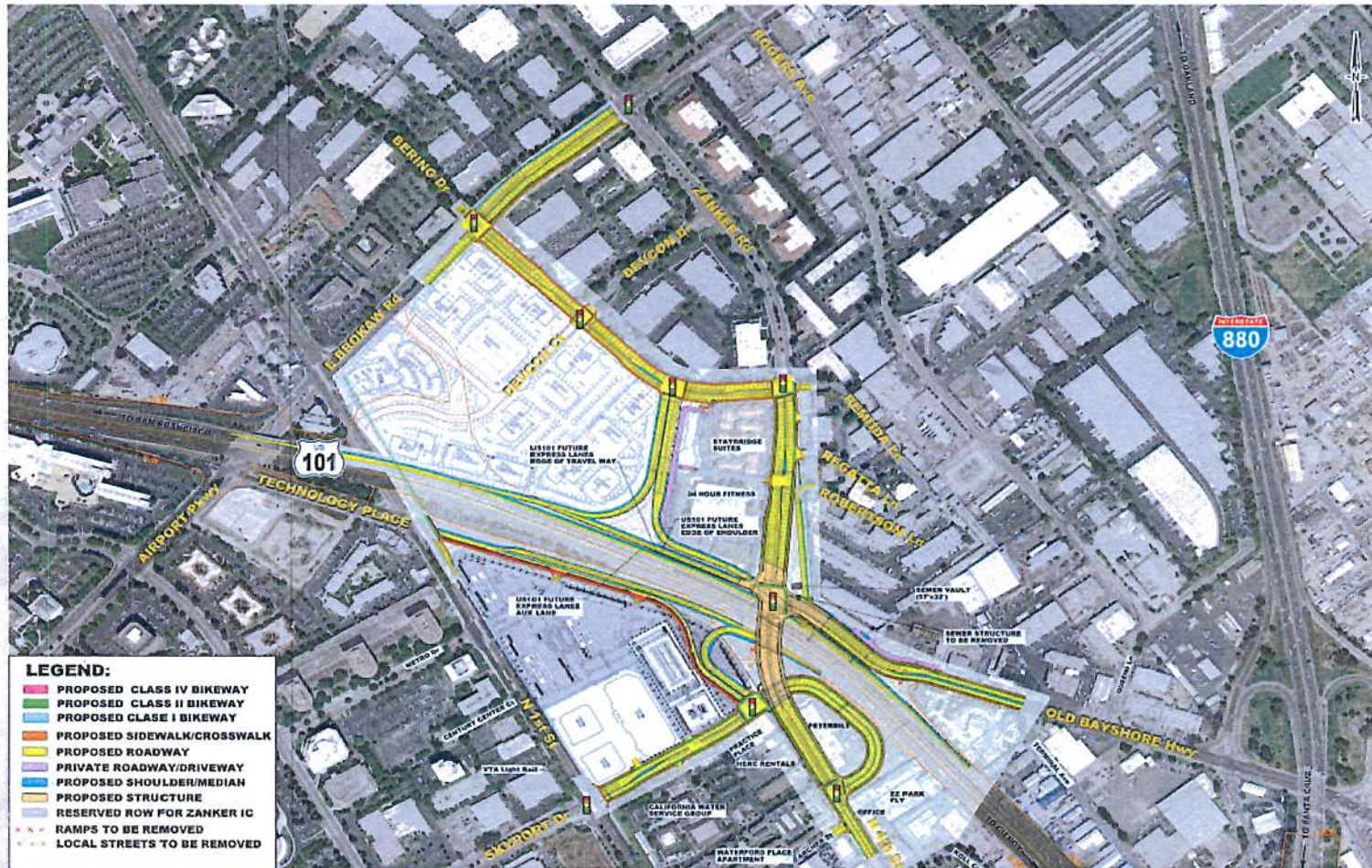
