# SUBJECT: Civil Service Commission Applications

DATE: November 4, 2019

### BACKGROUND

This Office routinely reviews applications for appointment to City boards and commissions. The applications generally do not provide complete information; however, they do occasionally disclose potential conflicts of interest or incompatible offices. The purpose of this memorandum is to highlight major areas of known potential conflicts that are disclosed by the applications.

### **COMMISSION DUTIES**

As established by the City Charter and authorized by the Municipal Code and Policy 0-4, the Civil Service Commission acts as an appellate body for certain personnel decisions affecting City employees and applicants for City employment. The Commission also makes recommendations to the Council and the City Manager and may conduct investigations concerning the administration of personnel in the Classified Service, reviews and recommends changes to Civil Service Rules, and appoints members of the City Council Salary Setting Commission.

### **COMMISSION COMPOSITION**

The Civil Service Commission consists of five members. City Charter section 1001(a) requires that one member must be an attorney who has practiced law in the State of California for at least five years and that the Civil Service Commission may not have more than four members of the same sex. Council policy also states that a Commissioner may not be a present, former, or retired City employee. [Policy 0-4,  $\SI(B)(1)$ , (3).]

Of the five positions, two Commissioners have expiring terms. The remaining three members include an attorney, and at least one male and female member. In addition, no application discloses any current or past City employment. Accordingly, both appointments can be made regardless of occupation or gender.

San Jose Municipal Code section 2.08.150(a) provides that the Charter controls the term for the Charter commissions. For the Civil Service Commission, the Charter provides that the term of office is four years, but it is silent on term limits. [Charter, §1001(b).] Thus, unlike other non-Charter Commissions, here, Commissioners may be reappointed for more than two terms.

# LEGAL CONFLICTS THAT MAY PRECLUDE VOTE OR PARTICIPATION

Certain positions may preclude a commissioner from participating in a commission discussion or from voting if a matter involving the entity comes before the commission. While this list is not complete, these types of conflicts generally fall within one or more of the following situations:

- An application shows entities that are "sources of income" to a potential commissioner within the 12 months preceding the start of the commission term, as defined under the Political Reform Act.
- An application shows sources of income to a Spouse or Domestic Partner of a potential commissioner within the 12 months preceding the start of the commission term.
- An applicant or the Spouse or Domestic Partner of an applicant is an Officer or Board Member of an entity and it is foreseeable that the entity could be involved in a matter coming before the commission.

# **APPEARANCE OF BIAS**

There may be facts which would not amount to a legal conflict of interest <u>requiring</u> a commissioner to recuse him or herself from a commission vote or discussion, but the relationship could create an appearance of bias on the part of the commissioner. City Council policy requires commissions to be free from bias in their decision making and may require a commissioner to recuse him or herself if the facts could reasonably lead one to conclude that the applicant would be biased for or against an entity or entities.

# APPLICANTS TO BE INTERVIEWED

<u>**Roy Truitt</u>** – Mr. Truitt applies for reappointment to the Commission. Mr. Truitt's application indicates that he is retired and currently sits on the Board of SCMF, a senior HUD housing foundation. His spouse is retired. Council Policy 0-4 provides that commissioner shall serve only one commission at a time. Mr. Truitt's application indicates he is applying for several of the Commissions. If Mr. Truitt is selected for T-2522/1666693\_2</u>

more than one Commission, he will have to choose only one position. Mr. Truitt's application discloses neither incompatible offices nor apparent conflicts of interest under current policies and statutes.

<u>Joan Smith</u> – Ms. Smith applies for reappointment to the Commission. Ms. Smith's application indicates that she is retired from her former employment as Chief Nursing Officer at Santa Clara Valley Medical Center. Ms. Smith's application discloses neither incompatible offices nor apparent conflicts of interest under current policies and statutes.

**Robert Gill** – Mr. Gill's application discloses that he is employed as an IHS Counselor for the County of Santa Clara and the General Manager of the Sikh Gurdwara. Mr. Gill's application indicates he is applying for two other Commissions, and that he was appointed to the Senior Citizens Commission. Council Policy 0-4 provides that commissioner shall serve only one commission at a time. The Clerk's records show Mr. Gill was deemed to have resigned from the Senior Citizens Commission as of November 21, 2018. Therefore, his application discloses neither incompatible offices nor apparent conflicts of interest under current policies and statutes.

#### CONCLUSION

The applicants do not appear to hold any incompatible office or have any apparent conflicts that would prevent them from serving on the Civil Service Commission. The Council may wish to consider the above comments in making its appointments to the Commission.
