Formalize the Police Department role of providing violent crime data and gang-related crime data (by MGPTF Hot-spots and Emerging Hot Spots) as part of the Bi-monthly report to PSFSS, as an annual presentation, and sharing this data each year with the MGPTF Technical Team and Policy Team.	Reports to both the PSFSS Committee and to the MGPTF Technical and Policy Teams are in place. The PSFSS Committee is scheduled to receive a report on violent crime data and gang related crime data under the Police Department Operations and Performance Bi-Monthly Status Report at its April 16, 2020 meeting. Reports on this data are also already in place under the Task Force's existing operating structure. During the monthly Task Force Technical Team meetings, and the quarterly Policy Team meetings, the Police Department presents the most current data on gang incidents citywide. Technical Team meetings include breakout sessions for each police division, wherein the Police Captain, PRNS Staff, and community service organizations discuss gang-activity trends.	Complete
	c. Direct staff to review and report out on the feasibility of segmenting future grants by target population profile to ensure that each segment has sufficient targeted services provided.	While the current funding allocation system distributes funding based on eligible services, target population is already a factor in the final award determination. For example, some of the eligible service areas, such as Street Outreach Intervention Services and Case Management Services, are already directed to the highest need youth. Some services may be provided to multiple Target Populations and it may be difficult to pre-determine the percentage of services that go to one or the other risk profile. If the Department is to adopt a more formal system for incorporating target population into the award process, staff recommends waiting until the standardized assessment tool is implemented (see Recommendation #4, above). An eight-member Policy Team working group comprised of City staff, other local government representatives, and community stakeholders met to develop a process for considering a name change to the Task Force. At the working group's direction, City staff will meet separately with nine key stakeholder groups before the end of 2019 to obtain new name suggestions. The top names preferred by stakeholder groups in that survey will be presented to the Task Force Policy Team at its January 2020 meeting, to make a final recommendation.	In progress
