SUBJECT: ADOPTION OF A RESOLUTION ACCEPTING THE 2020-2021 HAZARDOUS VEGETATION COMMENCEMENT REPORT COMPILED BY THE OFFICE OF THE SANTA CLARA ENVIRONMENTAL RESOURCE AGENCY, DEPARTMENT OF AGRICULTURE AND RESOURCE MANAGEMENT, DIVISION OF HAZARDOUS VEGETATION, DECLARING SEASONAL AND RECURRENT WEEDS AND REFUSE TO BE A PUBLIC NUISANCE, AND DIRECTING NOTICES BE SENT TO AFFECTED PROPERTY OWNERS.

RECOMMENDATION

Adopt a resolution:

- a) Accepting the 2020-2021 Hazardous Vegetation Commencement Report (see attached Weed Abatement Program Commencement Report) compiled by the Office of Santa Clara Environmental Resource Agency, Department of Agriculture and Resource Management, Division of Hazardous Vegetation;
- b) Declaring that those certain noxious or dangerous seasonal and recurrent weeds, growing or likely to be growing, and refuse, situated or likely to be situated, on those properties identified in the Report are a public nuisance; and
- c) Directing the Office of Santa Clara Environmental Resource Agency, Department of Agriculture and Resource Management, Division of Hazardous Vegetation to mail notices of a public hearing on January 28, 2020, at 1:30 p.m. before the City Council on the Report to property owners of affected real properties pursuant to Chapter 9.12 of Title 9 of the San José Municipal Code and the Weed Abatement Agreement between the City of San José and the County of Santa Clara.

OUTCOME

Adoption of this resolution will enable the City's contractor to commence the seasonal Hazardous Vegetation Program by identifying all vacant parcels in the City that will be covered by the program for the 2020-2021 season and begin notification to property owners.

BACKGROUND

The Hazardous Vegetation Commencement Report (Report) was compiled by the Office of the Santa Clara Environmental Resource Agency, Department of Agriculture and Resource Management, Division of Hazardous Vegetation pursuant to Chapter 9.12 of the San José Municipal Code and Weed Abatement Agreement between the County of Santa Clara and the City of San José. The Report, which sorts properties by Assessor's Parcel Number (APN), identifies where a dangerous accumulation of weeds is growing or likely to be growing or where a dangerous accumulation of refuse is situated or is likely to be situated upon streets, parkways, sidewalks, or vacant private properties in the City. Each year, these noxious or dangerous seasonal and recurrent weeds and refuse are declared to be public nuisance by resolution of the City Council.

ANALYSIS

The Report identifies the locations, assessor's parcel numbers, and owners of all properties that are proposed to be monitored under the Hazardous Vegetation Management Program. A copy of the Report is available for review in the Code Enforcement Office. The Department of Planning, Building and Code Enforcement has reviewed the Report and recommends that the City Council accept the Report. Further, it is recommended that the Council direct the County Environmental Resources Agency, Department of Agricultural and Resource Management, Division of Hazardous Vegetation to mail notices of a public hearing before the City Council on the Report to each property owner of real property listed on the Report. The notice will advise property owners of the date, time, and place of a public hearing before Council at which they will have the opportunity to voice any objections or concerns with regard to the inclusion of their property in the Hazardous Vegetation Management Program, as well as the proposed removal of such weeds and refuse. These notices also will contain information about required maintenance standards, abatement procedures and abatement charges.

The City contracts with the Santa Clara County Department of Agriculture and Environmental Management to abate fire hazards and nuisances caused by dry or overgrown vegetation on vacant properties. The City could elect to conduct an abatement program using City staff and equipment. However, undetermined costs would be incurred for the purchase, operation, and maintenance of equipment and to hire staff to administer and implement the abatement program.

The Department of Planning, Building and Code Enforcement has contracted with the County to provide weed abatement services as the County already possesses the necessary equipment, staff, and expertise to provide satisfactory abatement services at a reasonable cost.

CONCLUSION

The Report identifies properties with noxious or dangerous seasonal and recurrent weeds and refuse and proposes including them in the Hazardous Vegetation Management Program. Accepting the Report and adopting the resolution will allow the City's contractor to commence the seasonal Program by identifying all vacant parcels in the City that will be covered by the Program for the 2020-2021 season and begin notification to property owners.

EVALUATION AND FOLLOW-UP

The Hazardous Vegetation Management Program addresses the extent of yearly overgrown vegetation on private vacant properties and the reduction of such growth before the fire season starts. The Santa Clara Department of Agriculture and Resource Management will send a letter of notice with a Return Reply Form to all owners of vacant property in San José after the December 17, 2019 Council meeting. The Return Reply Form allows the owner to request that the County Contractor perform weed abatement work on their parcel or maintain their parcel in a manner consistent with the Minimum Fire Safety Standards from March 1, 2020, through the end of the fire season, which typically runs through October.

CLIMATE SMART SAN JOSE

The recommendation in this memorandum has no effect on Climate Smart San José energy, water, or mobility goals.

PUBLIC OUTREACH

The Office of the County Environmental Resources Agency, Department of Agricultural and Resource Management, Division of Hazardous Vegetation will mail notices of the date, time, and place of the public hearing to the property owners affected real properties pursuant to Chapter 9.12 of Title 9 of the San Jose Municipal Code.
