With three years of leadership experience, I currently serve as the Student Body Vice-President for the entire school. My role in ASB (Associated Student Body) is to represent the needs of every student, to ultimately progress toward an inclusive student community. As of now, we have coordinated school events to increase student participation and school spirit on campus, as well as listening to the concerns of the entire school community. For example, after receiving complaints about the dress code from numerous students, we are now working with our School Affairs Commissioner who attends the School Site Council Meetings to modify the dress code and better suit their needs. Another great example that highlights our impact on campus is our community benefit projects. Every year, the upcoming leadership board brainstorms a way that they could directly benefit the community. We have been able to come up with Supplies with Scholars which is essentially an initiative to provide necessary school supplies to those that wouldn't other able to afford. This previous year, I had the great opportunity of participating in my District 7 Youth Advisory Council (YAC). As a general member, I collaborated with my District 7 peers, including the former District Commissioner to create a District Project. Our District Project is aimed to tackle an issue that would hopefully do good to the youth of San Jose. We, as a collective, noticed recent problems with how the police were portrayed in a negative light to the youth. With that in mind, we decided to plan a day where police officers and teenagers would be able to engage in bonding activities and eat dinner to break the "bad cop" paradigm. I am also apart of Breakthrough Silicon Valley being a tutor. Breakthrough Silicon Valley is a program focused on the academic excellence of motivated, lowincome students with limited educational opportunities to prepare them for four-year colleges. As a tutor in the program, I help the students to improve their organizational skills to better manage their school work. In particular, I educate them on the importance of using a planner and the importance of having their school work organized. The summer I was also selected to be a tutor for the Read Write Discover program. It is a nonprofit organization that aims to combat illiteracy by giving children access to tutors over the summer. One of my main responsibilities was to work with younger children to help them develop and improve their reading and writing skills to better prepare them for the upcoming school year. Lastly, I am apart of a community service club called Interact. As a member, I volunteered in a variety of events ranging from working in a soup kitchen for the homeless and participating in a school beautification day to decorating the Senior Center for Christmas. Interact club encourages teenagers, like me to help and improve our community. Last year, we had a project called "The Right to Thrive" and its mission was to inspire hope through adversity. With this goal, we hope to empower our community of LGBTQ+ and those of minority all around the Bay Area.

I also see the power that we have as a collective. If selected to be a Youth Commissioner it would be my purpose to include every youth voice. I want to be able to create that safe environment where youth are actively engaged with decisions that affect them.

What do you feel are some of the problems facing the youth of San Jose?

Within this thriving community, there are so many motivated teenagers and children filled with great potential and promise to being the future leaders of San Jose; however, these very same people are also the ones to be quickly faced with problems that negatively impact them. From my own experience, I can speak out on one of these problems that is an insane amount of inequality occurring in school. School is supposed to be an environment where students are deliberately supported and encouraged to succeed. However, how can this environment be sustained if the resources simply aren't available to students. This problem occurs especially to minority groups and even first-generation student. The playing field is not to their advantage. Another problem that is ongoing is public safety. Public safety itself is a very broad subject where many things fall underneath this umbrella. Two of them would include youth gang affiliation and the drug and alcohol abuse. Just recently, I learned that my neighborhood, Seven Trees, was a gang hot spot. This is scary to me because there is a community center within Seven Trees where youth often come to but can also be a place of negative influence. Furthermore, a newer emerging problem in San Jose for the youth is a bad well-being resulted from a poor mental health. 20 percent of youth ages 13-18 live with a mental health condition. Because of this, stigma and discrimination are created against mental illnesses. Teenagers encounter much more in their daily lives, such as bullying and stress which all contributes to a poorer environment for the youth to thrive in.
