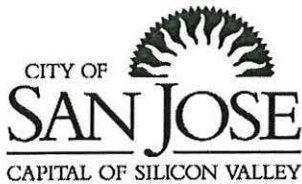

RECOMMENDATION

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Youth Advisory Council Litter Pickup will take place in the Ludlow neighborhood (D4) and is co-sponsored by Mayor Liccardo and the Parks, Recreation, and Neighborhood Service's Anti-Litter Program. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure
