



MONITORING

EOC Activation Level 4 MONITORING

WHEN INCIDENT TRIGGERS NOTIFICATION OF EMERGENCY

- Verify Information with City Council Liaisons
- Verify Messaging to Media & Constituents with City Council Liaison & EPIO
- Monitor The Incident, Report Possible Hazards/Threats





WHEN EMERGENCY CONTINUES TO ESCALATE

- Observe Emergency's Impact on Community
- Determine Whether or Not a DDO Should be Operational
- Review & Ratify Proclamation Of Local Emergency
- Maintain Regular Contact With City Council Liaison and Public



EOC Activation Level 1- FULL

WARNING

PROCLAMATION OF LOCAL EMERGENCY IS RATIFIED AND DDO IS DETERMINED TO BE NECESSARY

1. Follow Access Protocols in Plan to Enter & Set Up DDO at Designated Location
2. Establish & Maintain Communication with EOC City Council Liaison
3. Respond to Constituent Inquiries as Confirmed by EPIO
4. Survey Community and assist with reporting concerns or observations to the EOC through the City Council Liaison
5. Review Requirements for Special Legislation and Support Development of Disaster Related Policy.

THE DISASTER DISTRICT OFFICE IS...

- Conduit of real-world information for the EOC
- Force multiplier for emergency information
- **NOT** Incident Commander, First Responder



- Strength of OEM and cross agency collaboration
- Alert SCC (messages available in Spanish, English, Vietnamese)
- 39 Premise Use Agreements with schools
- 50 total pre-identified shelter sites
- Strengthened communication and liaison capabilities

Still, a Long Way to Go

Quake Ready 2023

- Initiate and compete emergency management service agreements.
- Complete deficiencies from 2017 Coyote Creek After Action Report.
- Additional FTE to implement OES Assessment, Staffing Report, Coyote Creek Recovery and Continuity of Government findings.
- A full Continuity of Government program.
- Emergency management multiyear training program: 75% of all employees and 100% of EOC and Recovery team.
- Implementation of funding sources from AB291 and State Budget Allocation
- Operationalized Power Vulnerability Plan

Quake Ready 2023

SUPPORTING OUR EMPLOYEES

- Established Continuity of Operations Plan
- Fully Operational Space for Emergency Operations and Contingency Operations
- Sustainable Emergency Public Information Officer (EPIO) Team
- Train All City Employees to Disaster Service Worker Standards

SUPPORTING OUR COMMUNITY

- Robust Community Emergency Response Team (CERT) Program
 - Graduates will continually augment their community's disaster preparedness capabilities
- LISTOS:
 - Preparedness program tailored to meet the individual needs of Spanish-speaking communities.
 - The program is delivered in a format that is both culturally and linguistically appropriate for the target population.

Opportunities

AB 291 (Chu)

Local Emergency Preparedness and Hazard Mitigation Fund (Sponsored by City of San Jose)

Status: Passed the Assembly Appropriations Committee on 1/23/20 and will be heard on the Assembly floor 2/20/2020

Creates a permanent funding source to support local government emergency preparedness efforts. Specifically, the bill:

- Establishes the Local Emergency Preparedness and Hazard Mitigation Fund.
- Requires Cal OES to establish a Commission with specified representatives to oversee funds.

Allocates funds in the following manner:

- 60% of revenue to local jurisdictions on a per capita basis with minimum funding levels.
- 25% to Operational Areas to establish a competitive grant process to support mitigation projects for the common benefit for two or more eligible local governments.
- 15% for high risk zones with vulnerable populations.

Requires a local government receiving funds to identify how the funds will be used and requires the locals to confirm these funds were used for that purpose.

Opportunities

2019 State Budget Allocation for San Jose

- Thanks to the leadership of **Assemblymember Kansen Chu**, with support from **Assemblymembers Ash Kalra, Evan Low**, and **Senator Jim Beall**, the City of San José received **\$5.5 million for emergency preparedness in the State Budget**.
- **\$2.5 million** of the funding will go to equipment for the new **San José Emergency Operations Center**.
 - This funding complements the November 2018 Measure T bond, which will fund the construction of Emergency Operations Center but is not able to fund furniture, fixtures, and equipment for the Center.
- **\$3 million** of the funding will go towards supporting the construction of the new **San José fire department training center**.
