#### BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

SBATF Membership Recognition Event was held on December 12, 2019 at Blue Door restaurant and sponsored by Vice Mayor Chappie Jones. This special event recognized members of the SBATF for their hard work and dedication for attending meetings and advising Councilmember Jones on public policy issues relevant to small business issues.

#### ANALYSIS

Retroactive approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Chappie Jones will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
