We would like to bring an item to the City Council meeting this Tuesday.

It's regarding our concern for the cell tower by Verizon to be installed in front of the Spiritual Center parking lot on Delmas Avenue. This is less than 250 feet between mine (████████) and Michelle's (████████).

Also I never got a notice from Verizon regarding this installation and heard from Michelle copied in here.

I am shocked and surprised that such a big decision can be made without more visibility to the neighborhood and that there is no public hearing for this.

We would request the city's help in delaying and re-considering this location which is in midst of a community with :

- small children
- older people whose property will be devalued when they are about to retire
- neighborhood nuisance due to noise
- aesthetic considerations.
- unknown health effects (I have not seen any medical document saying this is harmless)

I strongly urge that you put this on the agenda for 1/28 where our voices can be heard. We are hard-working residents who work full-time and pay our taxes and that request that the city hear our concerns and views on this.

I wholeheartedly agree with this request to add this item to the agenda to the City Council meeting this Tuesday, and to add public hearings on these matters. And I would also like to add my voice to Utpala's regarding concerns about this installation, which is site number "CA\_SJ\_SANJOSE\_WEST\_216".

Studies indicate that the presence of cell towers can devalue nearby properties by 20% or more. This is a terrible and unjustified potential risk, particularly given that existing wired and 4G tower infrastructure is more than sufficient. As Utpala points out, this can have a particularly negative impact on the older population nearing retirement, whose retirement security is based in large part on the value of their homes. Further, the aesthetics are poor and can easily ruin the quiet community feel of our street and Willow Glen in general. Data privacy concerns also should factor into the City's decision, as articles indicate that it is unlikely that there are currently sufficient protections in place to keep up with the data flow. Lastly, health concerns are also a major objection. Although we understand that FCC rules are implicated here, the City can and should consider health considerations in location placement of cell towers in residential zones. In particular, this installation is near a densely populated area, and one that frequently has large groups of children and the elderly nearby due to activity at the neighboring Spiritual Center.

Therefore, I echo the request below to delay and reconsider this location.
