# **RECOMMENDATION**

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Coffee Hour was held on Thursday, January 9, 2020 at Village Square Library and sponsored by Councilmember Arenas. This special event was a forum for the constituents of District 8 to be heard by their Councilmember and voice any concerns or issues. The event was free and open to the public.

#### **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Arenas will report any cash or in-kind donations received for the
