Please describe your experience in serving on a Commission or Board.

I worked as full-time staff for the Ventura County Transportation Commission from 2013-2017. The purpose of this commission is to manage and oversee the regional intercounty transit system throughout Ventura County and also serves as the county's congestion management agency. To that end, I was responsible for writing and presenting monthly staff reports to the commission. I provided special briefings to subcommittees and standing committees on an as-needed basis. Currently I work for the County of Santa Clara where I am responsible for staffing a citizen's committee called the Roads Commission. This commission makes reccommendations to the Board of Supervisors on county and other regional transportation issues and policy on an as-needed basis.

I am a licensed professional urban planner since 2010 and I have been a professional transportation planner since 2006. During my career I have gained experience working on mega-highway projects in WA and CA, such as serving as an Environmental Project Manager on the State Route 520 Floating Bridge in Seattle, WA and serving as a transportation planner on the US 101 HOV Lane Study in Ventura County. I am well familiar with how federal and state transportation funds are allocated to local jurisdictions. I am well familiar with working with agencies like Caltrans, the Metropolitan Transportation Commission (MTC), and the Valley Transportation Authority (VTA) and the role that these agencies play when it comes to transportation funds and grants. These skills and familiarity enable me with a deep and rich background for understanding any challenges or constraints of spending Measure T funding. Also, I think with my experience I can try to help educate or provide useful insight to my potential fellow Commissioners about infrastructure funding if they are less familiar or comfortable with specific topics.

What is your understanding of the purpose of the Commission?

The Measure T Oversight Commission is a requirement of the ballot measure to ensure a citizen presence and oversight role in the expenditure of public funds. The Oversight Commission will meet to listen to city staff's presentations and summaries of budgeted and spent funds. The Commission can make recommendations and ask questions to staff on the budgeting and expenditure of funds, as well as make recommendations to the City Council, who holds the authority to approve and/or make changes to the administration of Measure T.

Please list three issues facing the City that you feel the Commission should address.

1. Safety/Vision Zero and how the City can provide better resources from Measure T for roadway and traffic safety - either through strategic policy or strategic investments. 2. Maintenance of Existing Infrastructure. The City has the most dense network of roadways that it needs to maintain and maintaining roadways is not cheap and easy. Even though there are new revenues for transportation such as SB1 funds, the City is faced with the ongoing effort of prioritizing maintenance issues so that existing infrastructure doesn't fail. 3. Committing to investments in New Infrastructure. Building new transportation infrastructure such as Diridon Station, Berryessa BART, and Eastridge to BART Connector are huge investments that the City is faced with making major commitments to. The land use and development policies related to these developments impact the way in which the City could or should leverage its local transportation tax funds to ensure that these major infrastructure projects are successful in the future and recapture their value over time.
