RECOMMENDATION

Accept the semi-annual Open Government Report on posting of public calendars, public record request data, and data regarding posting of agendas and minutes of the City Council and decision-making bodies.

BACKGROUND

On August 21, 2007, the City Council approved a Rules and Open Government Committee recommendation requiring the Mayor and Council, Chiefs of Staff of the Mayor and Council offices, and certain Council Appointees to maintain calendars. Calendar entries are required to include, at minimum, all City-related appointments, including regular and special City Council meetings, public events or speaking engagements, meetings with developers, meetings with consultants, meetings with lobbyists, regional meetings and meetings of subcommittees or task forces. For each City-related appointment, the name(s), title(s), affiliated organization(s) and a general statement of the issues to be discussed should be included in the calendar entry. The City Council reaffirmed the calendar posting requirements on August 26, 2014, when the Consolidated Open Government and Ethics Provisions were approved.

The Administration prepares a compliance review twice a year covering the January-June and July-December periods and reports the results to the Rules and Open Government Committee. On August 22, 2017, the City Council approved a recommendation from the City Auditor, which was included in the 2017 Audit of Open Government, to add additional information about the status of open government, including public records requests and data regarding posting of agendas and minutes of the City Council and decision-making bodies in this semi-annual report.

ANALYSIS

Calendar Posting Compliance

The most recent calendar compliance review (Appendix A) was completed on January 7, 2020, for the period of July 1, 2019 through December 31, 2019. The review shows an average of 96.5% compliance, an increase from 93.7% in the last review (January 2019 to June 2019). Issues for noncompliance include:

- Postings appeared to only include standing meetings. Entries were replicated each week with little to no variation in the postings.
- Postings did not contain enough information to determine if the meeting met the criteria where the minimum details were required.
- Postings were not published on time.

Public Record Requests

For the period of July 1, 2019 through December 31, 2019, the City completed an estimated 2,138 Public Records Act requests (Appendix B). All Department Coordinators are required to track their requests. There continues to be an increase in the number of requests for "all communications" including emails, data on personal devices, and social media postings. The following table compares the number of requests completed during reporting periods over the past two years.

The City received two Public Records Act appeals during the period of July 1, 2019 through December 31, 2019. Mr. Andrew Hicks submitted his appeal on November 4, 2019. His appeal was heard in the Rules and Open Government Committee on January 22, 2020. Mr. Ken Gregoire submitted his appeal on December 3, 2019. His appeal was also heard in the Rules and Open Government Committee on January 22, 2020. The Committee denied both appeals.

Posting of Agendas and Minutes

The breakdown of the posting of agendas and minutes can be found in Appendix C. For the period of July 1, 2019 through December 31, 2019, the posting of agendas for the City Council, Council Committees, and decision-making bodies maintained the following average of compliance in meeting Sunshine Ordinance and Brown Act regulations:

• City Council: 100%

• Council Committee: 100%

• Decision-Making Bodies: 100%

Synopsis and minutes completion rates showed below are for the period of July 1, 2019 through December 31, 2019. The following is the average of compliance in meeting Sunshine Ordinance regulations through the Matrix of Public Meeting Requirements:

• City Council Synopsis: 77% completed

• City Council Minutes: 18% completed

• Council Committee Minutes: 31% completed

• Decision-Making Bodies Minutes: 88% completed

Decision-Making Bodies includes the Appeals Hearing Board, Board of Fair Campaign and Political Practices, Civil Service Commission, Deferred Compensation Advisory Committee, Planning Commission, Federated City Employees' Retirement Plan Board of Administration, Police and Fire Retirement Plan Board of Administration, and the Voluntary Employees Beneficiary Association Advisory Committee. The Council Salary Setting Commission did not meet during this time.
