BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The District 4 Health Fair was held on February 23, 2020 at the Berryessa Community Center and sponsored by Councilmember Lan Diep. This special event featured 16 healthrelated vendors who offered services and information to participants. Some of the services provided included mammograms for women over 40, blood pressure testing, mini massages, acupuncture, and much more. This special event was aimed at fostering a healthier and happier community. The event was free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Diep will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 4, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
