



Level	Description of Level	Programming Examples
Foundational	Foundational-level programs introduce basic concepts and ideas around healthy development, school readiness, and the role of the caregiver in providing quality care. This programming does not involve a long-term commitment.	Wee Connect, Habla Conmigo, Nana Y Yo, Ready4K, Health and Safety
Intermediate	Intermediate-level programs provide formal education around various topics of child growth and development. Classes may be offered in a series. Certificate of completion is provided for professional development hours completed.	College Courses, Grail Family Services Family Engagement Training, Child Development and Curriculum Development Trainings, First Aid and CPR, Health and Well-Being
Advanced	Advanced-level programs offer educational units, support towards licenses and/or certificates, and businesses. Caregivers will be offered opportunities to develop their skills as leaders, mentors, and coaches. Participants choosing to pursue a career in early education will be provided workshops and technical assistance. Hands-on opportunities to strengthen skills will be provided through practicum experience.	College Courses, Practicum, SOMOS Mayfair Provider Certification, Business Development Courses
