## RECOMMENDATION

Accept the Parks, Recreation and Neighborhood Services 2019 Community Impact Report.

## **OUTCOME**

This report will inform the Neighborhood Services and Education Committee of the Department of Parks, Recreation and Neighborhood Services performance, accomplishments, and results in achieving its goals during the 2018-2019 fiscal year.

## **BACKGROUND**

On December 10, 2019, the City Council approved ActivateSJ, the Department's new strategic plan, adopting a revised mission to connect people through parks, recreation and neighborhood services for an active San José. The plan is a people-first, service-driven strategy with five guiding principles: stewardship, nature, equity & access, identity, and public life. The principle of stewardship is the foundation that will ensure the Department takes care of what it has while providing a wide range of quality places and programs for all ages, cultures, and abilities.

The Department continues to provide creative programming and innovative events to meet the City Council's direction to pursue financially sustainable programming. Each year, in accordance with Council Policy 1-21, Pricing and Revenue Policy, 1 the Department is required to issue a report about how it has met the policy's goals to establish a financially sustainable approach to delivering services while retaining the Department's vision and mission. Enacted on June 16, 2009, at the height of the Great Recession, Council Policy 1-21 is a mechanism for allocating the use of public funds; creating a cost-recovery approach for various types of

recreational activities and facilities; maximizing the use of programs and facilities; and ensuring affordable access to programs and services. As such, it is the driver behind the cost-recovery goals presented in the Parks, Recreation and Neighborhood Services section of the City of San José's Fees and Charges document, which is approved by City Council through the annual budget development process.


## 2019 Financial Report


The Department continues to demonstrate financial stewardship each year, generating more than \$32.1 million of revenue in 2018-2019 to offset the Department's costs to the General Fund (35.3 percent cost recovery). This was an increase of \$803,827 (2.6 percent) from the previous fiscal year. Expenses continue to increase, which is indicated by a \$5.2 million (6.1 percent) increase in 2018-2019, in line with the Council-approved budget.

## **Equity, Access, and Scholarships**

The Department is committed to promoting access to disadvantaged residents, while maintaining the Department's ability to offset costs to the General Fund. With a goal to ensure that fees are not a barrier for any family looking to enrich their lives, the Department continues to grow its scholarship funds. In 2019, the Department provided \$1.2 million in scholarship funding compared to \$884,000 in 2018. This translated into the Department supplying 22 percent more scholarships (10,737 in 2019 compared to 8,837 in 2018) with 96 percent of awarded scholarship funds for leisure classes and programs being redeemed. To expand access and equitable opportunities across the City, the Department continues to build the scholarship program through the budget process and by pursuing partnerships resulting in program-specific sponsorships and grants.

While the 2018-2019 Adopted Operating Budget added \$100,000 in ongoing scholarship funds, the need for scholarships continue to grow and exceed the amount current funding can support. The Department continued to pursue created income (sponsorships, grants, and foundations) opportunities to promote affordable access with other public, private, and non-profit organizations. For example, the County of Santa Clara provided the Department with \$44,000 to support children in foster care, and the Gardner Family Health Network provided \$40,000 to support community members showing concerning health indicators. With partnerships like these, the City's ability to ensure equity and access expands. However, more access to funding is needed.

The Department continues to create financially sustainable programs to offset costs with a strong emphasis on creating access through a growing scholarship program. Overall participation continues to grow, demonstrating that the programs and services offered are valued by the community.
