Five-year funding plan

- Community Development Block Grant (CDBG)
 - \$8,947,319
- HOME Investment Partnership (HOME)
 \$3,319,683
- Housing Opportunities for Persons with AIDS (HOPWA)
 \$1,440,393
- Emergency Solutions Grant (ESG)
 - \$778,209

- Affordable housing including land acquisition and infrastructure subsidies
- Single family and mobilehome repair programs
- Enhanced and targeted code enforcement

- Support for community based housing development entities

 - Grassroots outreach skills development
