RECOMMENDATION

- (a) Accept the Spring Intergovernmental Relations Report.
- (b) Reaffirm all City positions summarized in the Intergovernmental Relations Priority Legislation Log.

OUTCOME

The Administration will continue legislative advocacy efforts to advance City priorities related to emerging critical policy issues and the Annual Legislative Program.

BACKGROUND

The Spring Intergovernmental Relations Report provides an update on the Council's top legislative and regulatory priorities and outlines legislative positions for Council reaffirmation. The Administration provides regular updates on legislative and regulatory advocacy efforts on behalf of the City to ensure the Council stays informed of actions the City has taken when the United States Congress and/or the California State Legislature is in session.

ANALYSIS

State Budget

On January 10, 2020 Governor Newsom submitted his 2020-21 California State Budget proposal to the Legislature. The total budget is \$222.2 billion, up by about \$7 billion from the 2019-20 State Budget. The proposed State Budget invests additional one-time and ongoing funds in several City priority areas:

- **Housing and Homelessness:** The Governor’s budget proposal includes \$10 million in General Fund revenues annually for the next three years to continue local housing production policy changes, including changes to local zoning and permitting processes and reducing the costs of development fees. Additionally, the Governor is proposing \$750 million in one-time General Fund revenues to establish the California Access to Housing and Services Fund. Revenues from this fund would flow through performance-based contracts between state and regional administrators. This is a shift from the model the state established under Governor Brown and continued with Governor Newsom last year to distribute flexible local funding to large cities, counties, and Continuums of Care, which are regional or local planning bodies that coordinate housing and services funding for homeless families and individuals.
- **Climate Resilience and Emergency Preparedness:** The Governor’s budget proposal calls for a climate resilience bond that includes \$250 million to invest directly in communities to support community resilience centers, and increase local preparedness, planning, and education around resilience. The Budget also includes \$50 million one-time General Fund dollars for “Community Power Resiliency” to support schools, county election offices, and food storage reserves that are vulnerable to utility-initiated power outage events. This proposal would support a matching grant program to help local governments prepare for, respond to, and mitigate the impacts of power outages.
- **Family Friendly/Early Education:** To increase child care access, the Governor’s budget proposes \$50 million ongoing funding from the Cannabis Fund to support more than 3,000 General Child Care slots previously funded from the General Fund, and \$10.3 million in cannabis revenue to add 621 new General Child Care slots. The Budget also proposes the establishment of a new Department of Early Childhood Development to allow for better services and outcomes for children in health and human services programs.

City’s Top Legislative and Regulatory Priorities

On December 3, 2019, the Council adopted the 2020 Legislative Program and Top Legislative and Regulatory Priorities list. The following is a status update of the Top Legislative and Regulatory priorities:

- **Homelessness Funding (State & Federal):** The City continues to work through the California Big City Mayors Coalition, the Governor, and legislative leadership on advocating for direct, flexible state funding to cities to address the homelessness crisis. On February 13, 2020, Mayor Liccardo testified at the Assembly Budget Subcommittee 6 on the results of previous state investments in local housing program and called for additional future investments. At the Federal level, the City is working with its Congressional representatives to ensure programs for affordable housing, including the Community Development Block Grant program (CDBG) and the HOME Investment Partnership (HOME), are funded through the appropriations process. In 2018-2019, the City received roughly \$14 million from these Federal programs for a range of services and programs including homeless outreach services

and rental assistance. In addition, the House Financial Services Committee recently passed H.R. 5187, the Housing is Infrastructure Act of 2019 on a 33-25 vote. The bill would significantly increase funding for critical affordable housing programs, including HOME and CDBG, to help address the nation's affordable housing crisis. Both Representative Lofgren and Representative Eshoo have co-sponsored the bill.

- **Statewide Emergency Preparedness Funding:** The City is sponsoring AB 291 (Chu), which would establish an ongoing statewide Local Emergency Preparedness and Hazard Mitigation Fund to help local governments meet emergency preparedness goals and boost programs that remain underfunded or neglected. The Assembly passed AB 291 and the bill is in the Senate. In the coming months, Assemblymember Chu will also put forward a budget request through the state budget process for an annual allocation to the Local Emergency Preparedness and Hazard Mitigation Fund.
- **Public Safety Power Shutoffs (State):** The City is sponsoring SB 378 (Wiener), which mitigates the negative impacts of utility planned blackouts by providing cost recovery for customers and local governments, levying a fine on utilities for each hour of a blackout, and requiring reports from the utility on the maintenance status and wildfire prevention investments. The Senate passed SB 378 and the bill is in the Assembly.
- **Immigration (State & Federal):** In February 2020, the Administration submitted public comment on the proposed U.S. Citizenship and Immigration Services Fee Schedule, which increases fees and eliminates fee waiver options for the most commonly used immigration benefit forms by low-income immigrants. The comments were also distributed to the City's Congressional delegation. The Administration will continue efforts to inform state and national immigration policy.
- **Transportation Reauthorization (Federal):** In February 2020, House Democrats released a five-year, \$760 billion framework for a transportation reauthorization package that prioritizes bringing the nation's infrastructure into a state of good repair and sets a path towards eliminating carbon emissions from the transportation sector. The Senate Environment and Public Works committee has passed its portion of the reauthorization with bipartisan support, which would dedicate \$287 billion in highway funding over the next five years.

The City joined the National Association of City Transportation Officials on a set of transportation reauthorization priorities including eliminating traffic fatalities on roadways, prioritizing user safety, providing additional resources for Complete Streets, expanding eligibility for U.S. Department of Transportation Smart City Challenge, and ensuring solvency of the federal Highway Trust Fund. The current authorization, Fixing America's Surface Transportation (FAST) Act is set to expire on September 30, 2020.

Other Key Advocacy Activities

- **Open Space and Affordable Housing Production:** The City is sponsoring SB 940 (Beall), which addresses implementation challenges with SB 330 (Skinner, 2019). SB 940 allows the City to up-zone properties for housing and “bank” that capacity for a year to down-zone open space, hillside, and public-quasi-public lands to match the General Plan. SB 940 will help the City encourage housing within our urban area and protect open space land outside of our Urban Growth Boundary. SB 940 is in the Senate Rules Committee awaiting committee assignment.
- **Cardrooms:** The Administration is actively monitoring a proposal by the Bureau of Gambling Control to change regulations on the player-dealer rotation practice in cardrooms, and a potential initiative to legalize sports betting in Tribal Gaming casinos and four racetracks in California sponsored by California Indian Gaming Tribes. Additionally, Senator Dodd and Assemblymember Gray introduced two placeholder bills, SCA 6 and ACA 16, around sports gaming as vehicles for a potential legislative response to the initiative. The Administration will continue to update Council on the development around the regulations, initiative, and legislation impacting cardrooms.
- **Mental Health:** The Administration is working closely with the County of Santa Clara to support efforts to increase funding for mental health and substance use programs. In his February 2020 State of the State address, the Governor called for better alignment of mental health services for the homeless and reform of Prop 63, the California Mental Health Care Act, which included a tax to support county-operated mental health systems. His message to counties was, “Spend your mental health dollars by June 30th, or we’ll make sure they get spent for you.” The City is supporting SB 854 (Beall), which expedites access to treatment by preventing health plans from requiring prior authorization when a patient needs an FDA-approved medication to treat a substance use disorder. The City also supports SB 855 (Wiener), which strengthens the California Mental Health Parity Act, requiring insurance companies to cover all medically necessary mental health and substance use disorder treatment.
- **e-Cigarettes and Flavored Tobacco:** The Administration submitted letters supporting national vaping legislation to Senator Feinstein and the San José Congressional delegation in December 2019. At the state level, the City is supporting SB 793 (Hill), which prohibits tobacco retailers from selling flavored tobacco products. Last week, the House voted to ban the sale of flavored cigarettes and e-cigarette liquids. The legislation goes further than the partial ban announced in January by President Trump. However, its fate is unclear in the Senate, where Senator Mitch McConnell, the majority leader who represents the tobacco-producing state of Kentucky, has not given any indication that he would bring it up for a vote.

- **Family Friendly:** The City continues advocacy around several state and federal bills focused on paid family leave and early childhood education. In December 2019, the President approved a defense spending bill that granted paid parental leave to federal workers. As the Administration identifies City priorities in the Governor's budget, it will work to access state budget and potential bond funding for San José's early learning and childcare programs.
- **2020 Census:** In mid-March 2020, U.S. households will begin receiving an official Census Bureau notice in the mail with information on how to respond to the 2020 Census. To ensure a fair and complete count, the Administration continues to focus on engaging legislators and coalitions around 2020 Census language access challenges, reaching hard to count communities and the homeless, and addressing potential technology issues with the online portal. The Administration hosted a briefing in early March 2020 with District Directors of the City's Congressional delegation to provide an update on City efforts and remaining challenges.

Intergovernmental Relations Business Plan

- **Supporting New and Emerging Coalitions:** The Administration continues to support the Mayor and Council engagement with new and emerging coalitions to advance City priorities both statewide and nationally. Key coalition activities include the following:
 - Big City Mayors Coalition – In January 2020, the California Big City Mayors Coalition appointed Mayor Liccardo as the chair. This Coalition of the thirteen largest cities in California is focused on advocating for additional funding to support local homelessness efforts.
 - League of California Cities – Councilmember Jimenez serves as the City's representative on the Board of the League of California Cities. Priorities for the League this year include improving the supply and affordability of housing and strengthening community and disaster preparedness, public safety, and resiliency. Vice Mayor Jones also serves on the Executive Committee of the Peninsula Division of the League.
 - National League of Cities – Vice Mayor Jones is hosting the National League of Cities' Large City Council Presidents Convening in San José from May 14-17, 2020. This is an opportunity to connect with peer cities throughout the nation on pressing policy challenges and an opportunity to showcase the policy work of the City. Additionally, Vice Mayor Jones represents the City on the National League of Cities' Information Technology & Communications Federal Advocacy Committee, which advises the national organization on broadband and smart cities policies.

- **Evaluating Opportunities with Sacramento Partners and Coalitions:** The Administration's work through the City's legislative advocates as well as other advocacy organizations continues to evolve. In addition, the Administration's ongoing work to analyze the critical policy windows and identify the Citywide Top Legislative Priorities based on Council direction enables the City to play a central role in statewide policymaking. As the legislative session unfolds, the Administration will leverage Sacramento partners and coalitions in support of City-sponsored bills and throughout the budget process.

City Positions and Actions Taken on Legislation: December 2019 – March 2020

Attachment A summarizes City positions and actions taken on legislation as of March 2020. While many of the positions and actions taken have already been approved by the Council through the Annual Legislative Guiding Principles and Program, Council is now asked to reaffirm all City positions summarized in the report.

CONCLUSION

The Administration will continue to actively engage legislators in support of the City's top legislative and regulatory priorities in 2020. The Administration also looks forward to new opportunities that will emerge through partners and coalitions.

EVALUATION AND FOLLOW-UP

The Administration will continue to advance the City's legislative program and will bring legislation forward for Council's consideration based on the appropriate legislative position adoption process (including the Standard, Expedited, Annual Legislative Guiding Principles and Program, and Legislative Delegation Request processes). The Administration will continue to report on all City legislative positions on a regular basis.

CLIMATE SMART SAN JOSE

The recommendation in this memo aligns with one or more Climate Smart San José energy, water, or mobility goals.

PUBLIC OUTREACH

The Administration will post this memorandum on the City's Council Agenda website for the March 24, 2020 Council Meeting.

COORDINATION

The Administration coordinated this memo with the City's state and federal legislative advocates; the City Attorney's Office; the Office of Economic Development; and the Departments of Community Energy; Housing; Human Resources; Library; Planning, Building, and Code Enforcement; and Transportation.
