**VTA Adjusts Service in Response to Coronavirus-related School Closures**

In light of today's announcement from the Santa Clara County Department of Public Health to close all public schools in the county for three weeks, we will suspend [school trip service](#) and reduce capacity on light rail vehicles, running one-car trains instead of two- and three-car trains. **This will take effect on Monday, March 16.**

To receive real-time service alerts, you can [subscribe to your routes in the Transit app](#).

We will continue to analyze ridership data to identify trends and will be making decisions on whether a change in the level of service is warranted and to what degree. This will be a large area of focus for VTA going forward to ensure we are responding appropriately to match our resources with the most effective level of service.
