BACKGROUND

Project Hope and various neighborhood associations surrounding Hoffman Via Monte are working with the District 10 Council office, to plan a neighborhood beautification day on March 28, 2020. Volunteers from the neighborhood associations will be working to help residents dispose and recycle their trash. In addition, the District 10 office will provide dumpsters, taking advantage of the \$18,000 budgeted in the FY 2019-2020 Operating Budget for community cleanups and dumpster days throughout District 10.
