Councilmember Johnny Khamis and Councilmember Dev Davis expressed concerns about the ordinance language, particularly the use of the term 'subsidy'. City Attorney Richard Doyle and Public Works Division Manager, Chris Hickey responded, and extensive conversation followed.

<u>Action</u>: On a call for the question, the motion carried, and **Ordinance No. 30292**, amending the San José Municipal Code to add a new Chapter 14.10 to Title 14 to set forth certain minimum labor standards, including prevailing wage requirements, for any private construction project accepting a public subsidy, was passed for publication. (9-0-2. Noes: Davis, Khamis.)

# 4.2 19-602 Council Policy Priority #4: Electronic Billboards - Approval of Scope and Timeline for Request for Proposals for Large Format Signage/Billboards on City-Owned Property.

Action: Upon motion by Councilmember Raul Peralez, seconded by Councilmember Sylvia Arenas and carried unanimously, the staff recommendations were accepted, including the memorandum by Councilmember Raul Peralez, Vice Mayor Chappie Jones and Councilmember Sylvia Arenas, dated August 2, 2019 to: Accept staff recommendation with the addition that (1) Any take-down proposal prioritizes existing billboards that are historically or currently blighted permitting lease conditions, and, (2) That City Staff provides clarification on a comprehensive timeline of the RFP process including issuance and award date.
