RECOMMENDATION

- (a) Approve award of a construction contract for the 2020 Local Streets Remove and Replace Asphalt Concrete Pavement Project, to the low bidder, O'Grady Paving, Inc., in the amount of \$2,515,471.
- (b) Approve an approximate ten percent contingency in the amount of \$251,500.

OUTCOME

Approval of this construction contract will provide required asphalt concrete pavement repairs along 56 miles of streets on the Local and Neighborhood Street Network to be surface sealed in the 2020 construction season. Approval of a ten percent contingency will provide funding for any unanticipated work necessary for the proper construction and completion of the project.

BACKGROUND

The Local and Neighborhood Street Network consists of approximately 1,490 miles of the City's streets, which collectively accounts for over 60% of the City's street network. The Department of Transportation (DOT) annually schedules streets to be surface sealed as a preventive maintenance measure to extend their useful life and reduce long-term maintenance costs to the City. The product to be used for surface-sealing is called "microsurfacing", which is a thin layer of asphalt emulsion blended with rock approximately 3/8 an inch in depth.

In 2020, DOT is planning to surface seal approximately 56 miles of Local and Neighborhood Streets throughout the City. The proposed contract is one of eight major pavement maintenance projects occurring on the Local and Neighborhood Streets Network during the 2020 construction season and is the subject of this memorandum.

Surface sealing is typically performed in two separate phases: preparation and a final surface sealing application. The preparation phase includes minor concrete repairs as well as ADA curb ramp installations and retrofits prior to the commencement of the pavement treatment. Streets to be surface sealed will also require the removal and replacement of any structurally failed areas of pavement. The final surface treatment is applied to the entire street after preparation phases are complete.

The City's Local and Neighborhood Street Network is organized into 135 geographically contiguous "Pavement Maintenance Zones" (PMZs). The PMZs were established several decades ago to support efficient planning and delivery of paving projects, maximize the amount of paving work completed at one time within a neighborhood area, and provide geographic equity of pavement maintenance across the City. Information provided by the City's pavement management database is used to identify candidate PMZs for preventive maintenance and sealing. The final list of PMZs to receive sealing was established using the following criteria:

- Funding availability and funding use restrictions
- Streets not affected by current or future street related projects
- Maintenance history and prescribed treatment schedules
- Community and City Council office feedback regarding roadway conditions and priority street segments
- Multi-year geographic spread across the City and street network

The Attachment to this memo contains the list of streets to be prepared for sealing. The list may change if unforeseen circumstances arise or new information regarding other street-related projects becomes available.

ANALYSIS

Bids were opened on March 12, 2020 with the following results:

The low bid submitted by O'Grady Paving, Inc. is \$2,515,471 and is 18.3% below the Engineer's Estimate. The Engineer's Estimate for this project is \$3,079,066.02. The estimate is based on bids received from similar past projects and current estimated construction prices. The bid is considered acceptable for the work involved in the project. Staff recommends that the construction contract be awarded to O'Grady Paving, Inc.

San Jose Municipal Code Section 27.04.050 provides that the contingency for all public works contracts (except those involving the renovation of a building or buildings) cannot exceed ten percent of the total contract amount. Staff recommends an approximate ten percent contingency, which should be sufficient to account for unforeseen conditions that might arise in the excavation, removal and replacement of failed concrete areas.

Construction is tentatively scheduled to begin in May 2020 and be completed by the end of August 2020.

CONCLUSION

Based on the evaluation of bids, the low bid is considered acceptable and staff recommends awarding the construction contract for the 2020 Local Streets Remove and Replace Asphalt Concrete Pavement Project to O'Grady Paving, Inc.

EVALUATION AND FOLLOW-UP

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation & Environment Committee, and the City Council. In addition to the project discussed in this memo, seven additional projects for the Local & Neighborhood Streets Network will be brought forward for Council action this Spring. Specifically, two contracts will involve preparation phase work, and five contracts will provide for sealing or resurfacing work on a combined total of 128 miles neighborhood streets.

CLIMATE SMART SAN JOSE

The recommendation in this memo has no effect on Climate Smart San José energy, water, or mobility goals.

PUBLIC OUTREACH

To solicit contractors, this project was listed on an online bid solicitation website, Biddingo, where bid packages were made available to download for contractor organizations and builders' exchange. When the project commences, the contractor will provide advance notification regarding working hours, duration of project, and any appropriate schedule and lane closures to affected businesses and residents, as stated in the specifications. To inform traveling motorists of upcoming construction activities and potential traffic delays, changeable message signs may be used on selected streets stating the scheduled date and time for work to occur on the street. This memorandum will be posted on the City's Council Agenda website for the April 21, 2020 Council Meeting.

COORDINATION

This project has been coordinated with the Department of Public Works, and this memorandum has been coordinated with the City Attorney's Office and the City Manager's Budget Office.
