Thank you for your memorandum recommending that the Rules Committee agenda a resolution condemning xenophobia and discrimination against Asian and Pacific Islander communities triggered by the COVID-19 pandemic.

I have been deeply saddened and disturbed by the rhetoric and anti-Asian sentiment as a result of this crisis. Hate crimes and racist attacks against APIs across our country have further amplified fear that has existed long before this pandemic. Our community must come together and residents must feel safe during this frightening time. Our essential workforce, made up significantly of APIs and other communities of color, must also feel safe and protected as they serve and respond on the frontlines. Adoption of this resolution sends a strong message that the City of San Jose defends our residents, and that racism and xenophobia is unacceptable will not be tolerated.

I thank you for your leadership on this issue and urge your Council colleagues to prioritize and support the item. AACI continues to oppose all forms of racial hate and aggression, and stands with the City to continue fighting for the health and safety of all our residents.

The Vietnamese American Roundtable (VAR) is a 501(c)3 non-profit whose mission is to mobilize, advocate for, and inform our community of the critical issues that impact their lives. We write in strong support of the Resolution proposed by Councilmember Raul Peralez to denounce xenophobia and anti-Asian sentiment while we must face the threat of COVID-19.

While our community has had to endure this pandemic, the Asian American Pacific Islander (AAPI) community has had to endure a disease that existed long before COVID-19 – racism. There have been plenty of stories about AAPIs facing verbal barrages, name calling, and even physical assaults across the nation.

These incidences have conveyed to our board and our volunteers that we must remain vigilant against misguided perceptions about the AAPI community and about COVID-19 itself. What has magnified our fears and concerns is what our board members themselves have witnessed and experienced. Friends have been verbally assaulted, our members have been harassed.

Disturbingly, we also face calls to step up and do more to address COVID-19 to prove our “American-ness.” AAPIs are on the frontline of this fight in our hospitals and research facilities. We are on the frontlines in law enforcement and government services. We are on the frontlines providing support to the community through the food supply chain, media, and volunteerism.

It is important that this Resolution denounce racism and prejudice in all its forms, and it is equally important that this Resolution recognizes that the AAPI community is already part of this community and part of the fight against COVID-19.

We urge the Council to support this Resolution.
