Recommendations:

As recommended by the Rules and Open Government Committee on April 22, 2020:

SUBJECT: CANCELLATION OF CITY COUNCIL COMMITTEE, BOARD, AND COMMISSION MEETINGS, WITH A FEW EXCEPTIONS AND UPDATES TO THE JANUARY – JUNE 2020 CITY COUNCIL COMMITTEE WORK PLANS

RECOMMENDATION

- (a) Approve the cancellation of City Council Committee, Board, and Commission meetings, with the exception of the Rules and Open Government Committee, Deferred Compensation Advisory Committee, Treatment Plant Advisory Committee, Federated Employees Retirement System Board, Police and Fire Department Retirement Board, Work2Future Board, Planning Commission, and Historic Landmarks Commission, from May 1, 2020 through June 30, 2020, and forward to the City Council meeting of April 28, 2020, for full City Council approval.
- (b) Approve updates to the January - June 2020 City Council Committee Work Plans as shown in Attachment A.

BACKGROUND

In response to the Stage 5 (Extremely High Response) of our Pandemic Management Plan related to COVID-19, combined with the Governor's Executive Order and Region-Wide Order both designed to slow the spread of COVID-19, the Rules and Open Government Committee and the City Council, on March 25, 2020 and April 7, 2020, respectively, ratified the City Manager's order to cancel all City Council Committee, Board, and Commission meetings from March 19, 2020 through April 30, 2020, with the exception of the following:

- 1) Rules and Open Government Committee;
- 2) Federated Employees Retirement System Board;
- 3) Police and Fire Department Retirement Board;
- 4) Work2Future Board;
- 5) Planning Commission; and
- 6) Historic Landmarks Commission.

As part of that memorandum, the work plan items related to the canceled City Council Committee meetings for that time period were approved to be either dropped and instead be issued as an Information Memorandum by April 30, 2020, dropped and instead to be placed on a City Council meeting by June 30, 2020, deferred to a new date to be determined, or dropped from the work plan.

Finally, a waiver for the Fiscal Year 2019-2020 requirements of Part 46 of Chapter 4.80, and Chapters 17 and 17.23 of the San José Municipal Code for annual review of the budget for the Housing Trust Fund and for annual review of fees and budgets for the Rent Stabilization Program by the Housing and Community Development Commission was approved.

The memorandum also stated that if the City Council Committee, Board, and Commission meetings cancellation order needed to be extended, the Administration would return to the Rules and Open Government Committee in April 2020 for further approval.

ANALYSIS

Cancellation of City Council Committee, Board, and Commission Meetings

Because of the Administration's continuing requirement to execute our Pandemic Management Plan related to COVID-19 and in preparation for the Administration to hopefully move from response to recovery mode before the end of the fiscal year, the cancellation of City Council Committee, Board, and Commission meetings from May 1, 2020 through June 30, 2020, with the exception of the following, is now recommended:

- 1) Rules and Open Government Committee;
- 2) Deferred Compensation Advisory Committee;
- 3) Treatment Plant Advisory Committee;
- 4) Federated Employees Retirement System Board;
- 5) Police and Fire Department Retirement Board;
- 6) Work2Future Board;
- 7) Planning Commission; and
- 8) Historic Landmarks Commission

It should be noted that Deferred Compensation Advisory Committee and Treatment Plant Advisory Committee meetings were cancelled for the period of March 19, 2020 through April 30, 2020, but are now recommended to proceed for the May 1, 2020 through June 30, 2020 time period. The exceptions are explained as follows:

- The Rules and Open Government Committee meetings are not recommended to be cancelled because the Committee is responsible for ensuring accessible, responsive, transparent and accountable government in the setting of City Council agendas.

- The Deferred Compensation Advisory Committee meetings are not recommended to be cancelled due to the Committee's fiduciary responsibility to plan participants, including the regular review of investment options, and to ensure any of the Coronavirus Aid, Relief, and Economic Security (CARES) Act provisions related to 457 Defined Contribution Plans are implemented in a timely manner.
- The Treatment Plant Advisory Committee meetings are not recommended to be cancelled as the master agreement for the San Jose-Santa Clara Regional Wastewater Facility calls for the co-owner, City of Santa Clara, along with the associated tributary agencies, to hear and make recommendations to the City Council on issues related to the Wastewater Facility.
- The Federated Employees Retirement System Board and Police and Fire Department Retirement Board meetings are both not recommended to be cancelled as the two Boards still need the ability to approve retirement applications for member employees as well as make investment decisions related to the current volatility in the financial markets.
- The Work2Future Board meetings are not recommended to be cancelled as meetings are needed to approve budgets for funding purposes as related to Federal law requirements and regulations, specifically 20CFR 679.370(I) requirements, in order to bring on new contractors for youth and adult employment services that will likely be needed in anticipation of a surge in unemployed and underemployed individuals.
- The Planning Commission meetings are not recommended to be cancelled because the Planning Commission was established in Article X of the City of San José City Charter, as approved by the voters of the City, to carry out certain functions, which functions are needed for the performance of City services which have been determined to be essential services. Continuation will ensure that development projects can proceed from the planning to building phase as expeditiously as possible after the emergency, which will help stimulate the economy, provide housing, and benefit the City budget.
- Although not mandated by the City Charter like the Planning Commission, Historic Landmarks Commission meetings are not recommended to be cancelled as, like the Planning Commission, they are needed to ensure development projects can proceed during this time.

If it is later determined that a Committee, Board, and Commission must meet during the cancellation period for an urgent and/or emergency matter, a request for an exception will be brought to the Rules and Open Government Committee for consideration with a detailed explanation outlining the urgent and or emergency nature of the meeting request.

January - June 2020 City Council Committee Work Plans

Similar to the previous disposition of City Council Committee Work Plan items for the March 17, 2020 through April 30, 2020 time period, Attachment A provides a list of the approved January – June 2020 City Council Committee Work Plan items for Committee meetings that are recommended to now be cancelled between May 1, 2020 and June 30, 2020. Staff has again worked with each City Council Committee Chair to determine the disposition of those items. On

City Council Meeting	Report to be dropped from the work plan and instead be placed on a City Council meeting before June 30, 2020 as the item has specific requirements that will need full City Council approval.
Defer to August 2020 – December 2020 Council Committee Work Plan	Report to be deferred to the August 2020 – December 2020 City Council Committee Work Plan. The new date for the item will be determined as part of the development and approval of the August – December 2020 City Council Committee Work Plan that will be agendized for Rules and Open Government Committee consideration in June 2020.
Drop	Report to be dropped from the work plan because the nature of the information will no longer be timely or because the regular reporting of the item will be heard as part of the next update.

CONCLUSION

As stated in the prior memorandum on this issue, the Administration appreciates the City Council and community's patience as we attend to our emergency response to COVID-19 and focus on essential services, while also adhering to the Governor's Executive Order and Region-Wide Order both designed to slow the spread of COVID-19. The cancellation of the City Council Committee, Board, and Commission Meetings, with the exception of the Rules and Open Government Committee, Deferred Compensation Advisory Committee, Treatment Plant Advisory Committee, Federated Employees Retirement System Board, Police and Fire Department Retirement Board, Work2Future Board, Planning Commission, and Historic Landmarks Commission, through June 30, 2020 will continue to ensure the Administration can focus on the most important activities and services related to our COVID-19 response and, hopefully, recovery efforts in the near future. The recommended disposition of the City Council Committee Work Plan items from May 1, 2020 through June 30, 2020 will help provide that focus and ensure that the most important items are brought forward appropriately.


