INCREASES FOR RENT STABILIZED APARTMENTS AND MOBILEHOMES.

SUSPENSION OF LATE FEE CHARGES FOR APARTMENT RENT

#### REASON FOR SUPPLEMENTAL

This supplemental memorandum includes a list of annual anniversary dates for rent increases in mobilehome parks throughout San José.

#### **BACKGROUND**

The City of San José is home to 59 mobilehome parks, about 10,838 space lots, with an estimated 30,000 - 35,000 residents living in the mobilehome park communities. The Mobilehome Rent Ordinance was passed in 1987 and applies to all mobilehomes in San José.

#### **ANALYSIS**

The Mobilehome Rent Ordinance, Chapter 17.22.155 outlines the mechanism by which mobilehome park owners may annually increase rent, known as the "Maximum Standard Annual Percentage Increase." The Ordinance limits annual rent increases to 75% of the San Francisco-Oakland Consumer Price Index (CPI) with a minimum of 3% and a maximum of 7%. Chapter 17.22.450.B provides that if a rent increase has not been implemented in more than 24 months, the rent may be increased by the combined total of the allowable annual rent increase for the

current and previous year. City Staff has provided a listing of all mobilehome park anniversary dates (Attachment A). The typical process for mobilehome parks is to provide a 90-day notice to residents prior to the anniversary date of the annual rent increase. According to Attachment A, seven mobilehome parks have an April 1 anniversary date and an additional 11 parks with anniversary dates in May 1 and June 1.

The Moratorium on Rent Increases, if passed, would suspend the Maximum Standard Annual Percentage Increase, until December 31, 2020. Suspension would require mobilehome park owners to postpone the collection of the annual increase if the rent increase was set to occur during the moratorium. However, the Mobilehome Rent Control Ordinance states that after more than 24 months have elapsed since the last effective rent increase, a park owner may calculate and charge the combined allowable maximum rent increase for the current and previous year.

For example, if a mobilehome park owner typically increases rent in July, and expected to do so in July 2020 then, in compliance with this Moratorium on Rent Increases, the park owner would be unable to charge and collect the increased rent. The mobilehome park owner may increase the rents on January 1, 2021 following the expiration of the Moratorium on Rent Increases. As an alternative, in August 2021, the park owner would be permitted, under the existing Mobilehome Rent Ordinance Chapter 17.22.450.B, to increase rent equal to the cumulative total of the maximum annual percentage increase for the current year (in this example, year 2021) and the previous year (in this example, year 2020), because the last effective date of the of rent increase was in 2019.
