The Council of the City of San José convened in Regular Session on Tuesday, April 9, 2019, at 9:35 a.m. in the Council Chambers at City Hall.

2.7 19-175 Amendment to the Agreement with Host International Inc. for Food and Beverage Concession at the Airport.

Approve the Fifth Amendment to the Host International Inc. Food and Beverage Concession Agreement to extend the term of the agreement for two years, from June 30, 2026 to June 30, 2028, modify the Street Pricing Policy from 10% to 13% above street pricing, add a new concession into the Terminal B Interim Facility, refresh the Terminal B food court, reduce the Joint Marketing Fund Fee from .50% to .25% of gross revenues, and modify the use of the Joint Marketing Fund to include customer service initiatives. CEQA: Not a Project, File No. PP17-003, Agreements/Contracts (New or Amended) resulting in no physical changes to the environment. (Airport)

<u>Public Comments</u>: Eight members of the public, including Ken Yeager, Claudia Shope, Roxanne, Gabrielle Antolovich and Paul Escobar expressed opposition to the lease with Chick-fil-A, citing the company's exclusionary policies regarding LGBTQ rights.

Discussion followed, with clarification and insights provided by City Attorney Richard Doyle and Director of Aviation, John Aitken.

<u>Motion</u>: Councilmember Dev Davis moved approval of the staffs' recommendations, with direction as indicated below in "Action". The motion was seconded by Councilmember Magdalena Carrasco.

Action: On a call for the question, the motion carried unanimously, with staffs' recommendations approved, with the additional language to withhold the two-year extension from any operator that does not operate 7 days per week, and with direction to the City Attorney to work on language for future contracts to reflect the City's values. Additionally, direct rainbow and transgender flags to be displayed at the airport. (11-0.)

Director of Housing Jacky Morales-Ferrand provided a presentation, and she and Deputy Director of Housing, Rachel VanderVeen responded to questions from Council.

<u>Public Comments</u>: Eight members of the public spoke to the issue of the housing crisis, a need for a preservation strategy and offered support for the efforts of the Housing staff.

<u>Motion</u>: Councilmember Maya Esparza moved approval of the staffs' recommendations, with changes as outlined in the memorandum she coauthored with Councilmember Dev Davis, and including Vice Mayor Chappie Jones memorandum with recommendations as amended and noted below in "Action". Councilmember Dev Davis seconded the motion.

Action: On a call for the question, the Affordable Housing Investment Plan Update was accepted, including the joint memorandum from Councilmembers Esparza and Davis, dated April 9, 2019 to include the new priorities of funding acquisition and/or rehabilitation of existing market rate housing, and to increase the minimum of 30% of funds invested in extremely low-income housing to 45% of funds over the life of the Housing Investment Plan; also including the following from the memorandum from Councilmember Jones, dated April 9, 2019: Request a follow-up from staff following the Notice of Funding Availability (NOFA) detailing how the \$10 million in funding will be allocated for the acquisition and/or rehabilitation of existing market rate housing. (11-0.)

<u>Public Comments</u>: Fourteen members of the public offered comments and recommendations, both supporting the preservation of mobile home parks and those in opposition to AB 705.

<u>Motion</u>: Councilmember Sergio Jimenez moved approval his memorandum dated March 28, 2019 offering support to AB 705. The motion was seconded by Councilmember Maya Esparza.

Councilmember Dev Davis and Mayor Sam Liccardo offered friendly amendments, noting they could support the motion if modified to clarify greater flexibility as noted below in "Action". Councilmembers Jimenez and Esparza accepted the amendment/s.

<u>Action</u>: On a call for the question, the motion carried unanimously, and a position of support was adopted with clarification that it comport with the Council's intent that there is some flexibility in the new housing provided. (11-0.)
