2. AB 59 (Kalra) - Elections: Polling Places: College and University Campuses. (City Manager).

<u>Public Comment</u>: Blair Beekman commented on, and expressed gratitude for more polling places on college campuses, lauding this as an important, positive development in the democratic process.

<u>Action</u>: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Dev Davis, and carried unanimously, AB 59 (Kalra) - Elections: Polling Places: College and University Campuses, was approved and added to the June 11, 2019 Agenda. (5-0)

3. Response to Rise in Sexual Assaults in San José (Arenas, Carrasco, Davis, Esparza, Foley).

Councilmember Sylvia Arenas noted the case of a 14-year-old girl who had been kidnapped in Chicago and held against her will on the edge of Districts 7 and 8. She reached out via the helpline to escape from this human trafficking operation.

<u>Public Comment</u>: Offering comments on Response to Rise in Sexual Assaults in San José were: Kim Walker, (representing Sexual Assault Forensic Examiners); and Blair Beekman.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Councilmember Dev Davis, and carried unanimously, Response to Rise in Sexual Assaults in San José, was approved, (greenlighted). (5-0)

4. Citywide Anti-Displacement Strategy Study. (Carrasco)

Frances Herbert addressed the Committee on behalf of Councilmember Carrasco's memo to schedule a study session to address displacement.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas to move approval, seconded by Vice Mayor Chappie Jones, and carried unanimously, Citywide Anti-Displacement Strategy Study, was approved, (greenlighted). (5-0)

<u>Public Comment</u>: Nathan Brittsay commented on a newspaper story of trains blaring horns through downtown San José, and stated that the railroad in question is next to his house, some 20 feet away. This causes him serious sleep deprivation, resulting in health problems.

<u>Action</u>: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Dev Davis, and carried unanimously, the Union Pacific Property was approved, (greenlighted). (5-0)
