A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING THE RENAMING OF CHAMPIONS DRIVE TO WONDO WAY, A PUBLIC STREET EXTENDING APPROXIMATELY 2.000 FEET NORTHWEST OF INTERSECTION ITS WITH EARTHQUAKES WAY TO THE CITY BOUNDARY OF THE **CITY OF SANTA CLARA**

WHEREAS, the applicant, San José Earthquakes, LLC, has submitted an application with the Department of Planning, Building and Code Enforcement requesting to rename Champions Drive to Wondo Way, a public street extending approximately 2,000 feet northwest of its intersection with Earthquakes Way; and

WHEREAS, a map depicting the approximately 2,000-foot long Public Street, Champions Drive, located northwest of Earthquakes Way, is attached hereto as <u>Exhibit</u> <u>"A"</u> and incorporated fully herein by this reference; and

WHEREAS, pursuant to City Council Policy 6-5 entitled "Street Naming and Renaming" ("Council Policy 6-5"), the City Council is responsible for the naming and renaming of public streets, boulevards, avenues, drives, courts, circles, and other public and private rights-of-way; and

WHEREAS, Champions Drive is an existing public street that extends approximately 2,000 feet northwest of Earthquakes Way to the city boundary of the City of Santa Clara with the remainder of the street in the City of Santa Clara; and

WHEREAS, the street name change from Champions Drive to Wondo Way in the City of San José shall not take effect until the effective date of a street renaming action from

Champions Drive to Wondo Way for the balance of the street by the city of Santa Clara; and

WHEREAS, San José Earthquakes, LLC and Coleman Highline, LLC are the owners of all parcels that are currently accessed from Champions Drive, and the City has received written confirmation from Coleman Highline, LLC that they support the change of the public street name from Champions Drive to Wondo Way; and

WHEREAS, pursuant to Council Policy 6-5, the Department of Planning, Building and Code Enforcement determined the proposed renaming of Champions Drive to Wondo Way is a renaming of a minor public street and therefore, subject to a more streamlined process since not more than twenty (20) occupied parcels are affected by the proposed renaming; and

WHEREAS, pursuant to the Council Policy on Public Outreach 6-30, San José Earthquakes, LLC, posted a sign at the site notifying the public of the proposed street renaming and identifying how to obtain additional information or submit comments, and received no public comments; and

WHEREAS, pursuant to and in accordance with Chapter 20.100 of Title 20 of the San José Municipal Code, this City Council conducted a hearing on said application, notice of which was duly given; and

WHEREAS, at said hearing this City Council gave all persons full opportunity to be heard and to present evidence and testimony respecting said matter; and

WHEREAS, at said hearing, this City Council received and considered all of the comments, reports and recommendations of the City's Director of Planning, Building and Code Enforcement; and

WHEREAS, pursuant to provisions of Section 15061(b)(3) Review for Exemption of the State Guidelines for Implementation of the California Environmental Quality Act of 1970 (CEQA), this project is found to be exempt from the environmental review requirements of Title 21 of the San José Municipal Code, implementing CEQA, as amended;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1: Pursuant to the provisions of Section 34091.1 of the Government Code of the State of California and Council Policy 6-5, this Council does hereby find and determine that the approximately 2,000-foot public street, Champions Drive, as indicated on Exhibit "A" hereto, shall be renamed from "Champions Drive" to "Wondo Way" to the city boundary of the City of Santa Clara and located in the City of San José, and that said City Council does hereby rename said street upon the date of adoption of this Resolution.

SECTION 2: The street name change from Champions Drive to Wondo Way in the City of San José shall not take effect until the effective date of a street renaming action from Champions Drive to Wondo Way for the balance of the street by the City of Santa Clara; and

SECTION 3: The City Clerk is hereby directed to deliver a copy of this resolution to the Board of Supervisors of the County of Santa Clara.
