A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE (A) AUTHORIZING THE CITY MANAGER OR DESIGNEE TO SUBMIT A REQUEST то THE METROPLITAN TRANSPORTATION COMMISSION ("MTC") FOR THE ALLOCATION OF FISCAL YEAR 2020-2021 TRANSPORTATION DEVELOPMENT ACT, ARTICLE 3 ("TDA3") STATE GRANT FUNDING IN THE AMOUNT OF \$1,058,096 FOR BICYCLE AND PEDESTRIAN PROJECTS: (B) MAKING THE CERTIFICATIONS AND ASSURANCES REQUIRED UNDER THE TDA3 GRANT; AND (C) AUTHORIZING THE CITY MANAGER OR DESIGNEE TO ACCEPT TDA3 GRANT FUNDING AWARDED FROM MTC, AND TO NEGOTIATE AND EXECUTE ANY GRANT DOCUMENTS TO EFFECTUATE THE GRANT

WHEREAS, Article 3 of the Transportation Development Act ("TDA3"), Public Utilities Code ("PUC") Section 99200 et seq., authorizes the submission of claims to a regional transportation planning agency for the funding of projects exclusively for the benefit and/or use of pedestrians and bicyclists; and

WHEREAS, the Metropolitan Transportation Commission ("MTC"), as the regional transportation planning agency for the San Francisco Bay region, has adopted MTC Resolution No.4108, entitled "Transportation Development Act, Article 3, Pedestrian and Bicycle Projects," which delineates procedures and criteria for submission of requests for the allocation of TDA3 funding; and

WHEREAS, the MTC selects projects based on recommendations from member agencies, and the Santa Clara Valley Transportation Authority coordinates the local project selection process; and

WHEREAS, the TDA3 grant program generally funds minor (low cost) pedestrian and bicycle projects and for Fiscal Year 2020-21 the City of San José ("City") expects to receive \$1,058,096 in guaranteed TDA3 funds, which is proposed to be used for Citywide projects including installation of bikeways, pedestrian safety improvements, as well as citywide bicycle safety and education; and

WHEREAS, no local matching funds are required; and

WHEREAS, MTC Resolution No. 4108 requires that requests for the allocation of TDA3 funding be submitted as part of a single, countywide coordinated claim from each county in the San Francisco Bay region; and

WHEREAS, the City desires to submit a request to MTC for the allocation of TDA3 funds to support the projects described in Attachment B to this Resolution, which may be amended from time to time;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

- The City of San José declares it is eligible to request an allocation of TDA Article (a) 3 ("TDA3") funds pursuant to Section 99234 of the Public Utilities Code; and
- (b) There is no pending or threatened litigation that might adversely affect the project or projects described in Attachment B to this resolution, or that might impair the ability of the City of San José to carry out the project; and
- (c) The projects have been reviewed by the Bicycle & Pedestrian Advisory Committee of the City of San José; and

- (d) The City of San José attests to the accuracy of and approves the statements in Attachment A to this resolution; and
- A certified copy of this resolution and its attachments, and any accompanying (e) supporting materials shall be forwarded to the congestion management agency of the County of Santa Clara for submission to MTC as part of the countywide coordinated TDA3claim; and
- (f) The City Manager or designee is authorized to accept any grant funding awarded from MTC, and to negotiate and execute any grant documents necessary to effectuate the grant.

Re: Request to the Metropolitan Transportation Commission for the Allocation of Fiscal Year 2020-2021 Transportation Development Act Article 3 Pedestrian/Bicycle Project Funding

Findings

- 1. That the City of San José is not legally impeded from submitting a request to the Metropolitan Transportation Commission for the allocation of Transportation Development Act (TDA) Article 3 funds, nor is the City of San José legally impeded from undertaking the project(s) described in "Attachment B" of this resolution.
- 2. That the City of San José has committed adequate staffing resources to complete the project(s) described in Attachment B.
- 3. A review of the project(s) described in Attachment B has resulted in the consideration of all pertinent matters, including those related to environmental and right-of-way permits and clearances, attendant to the successful completion of the project(s).
- 4. Issues attendant to securing environmental and right-of-way permits and clearances for the projects described in Attachment B have been reviewed and will be concluded in a manner and on a schedule that will not jeopardize the deadline for the use of the TDA funds being requested.
- 5. That the project(s) described in Attachment B comply with the requirements of the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.).
- 6. That as portrayed in the budgetary description(s) of the project(s) in Attachment B, the sources of funding other than TDA are assured and adequate for completion of the project(s).
- 7. That the project(s) described in Attachment B are for capital construction and/or design engineering; and/or for the maintenance of a Class I bikeway which is closed to motorized traffic; and/or for the purposes of restriping Class II bicycle lanes; and/or for the development or support of a bicycle safety education program; and/or for the development of a comprehensive bicycle and/or pedestrian facilities plan, and an allocation of TDA Article 3 funding for such a plan has not been received by the City of San José within the prior five fiscal years.
- That the project(s) described in Attachment B is included in a locally approved 8. bicycle, pedestrian, transit, multimodal, complete streets, or other relevant plan.

- 9. That any project described in Attachment B that is a bikeway meets the mandatory minimum safety design criteria published in Chapter 1000 of the California Highway Design Manual.
- 10. That the project(s) described in Attachment B will be completed before the funds expire.
- 11. That the City of San José agrees to maintain, or provide for the maintenance of, the project(s) and facilities described in Attachment B, for the benefit of and use by the public.
