# SJPD Jurisdiction

All areas ***outside*** the BART station building and operating corridor including:

- a) the facilities used for bus and paratransit operations
- b) the parking garage and surface lot,
- c) all easement areas, all track right-of-way areas, and all areas under the elevated structure

BART PD will provide law enforcement services ***within*** the station building, police zone facility, and the BART operating corridor.

**Hours of Operation:** Weekdays (4:00 am - Midnight)

Saturday (6:00 am - Midnight)

Sunday (8:00 am - Midnight)

7 Days a Week/365 Days a year



# TIMELINE

- ▶ March 15, 2019: VTA issued the RFP for Supplemental Law Enforcement Support Serviced for the Berryessa/North San José BART Station
- ▶ April 17, 2019: SJPD Submitted Proposal to VTA.
- ▶ September 2019: Original Bid awarded to the SCC Sheriff's Office.
- ▶ January 2020: Re-entered negotiations with VTA.
- ▶ April 17, 2020: Notice of Recommended Award to SJPD.
- ▶ May 7, 2020: VTA Board approved the contract with SJPD.
- ▶ July 1, 2020: Contract begins



# QUALIFICATIONS

- ▶ BART Station: SJPD jurisdiction including the surrounding neighborhoods.
  - Consistent safety priorities for both the station and the surrounding area.
  - Avoids duplication of police services and responses.
  - Law enforcement accountability in our own city.
  - Policies/procedures/training and use of force are consistent.
  
- ▶ SJPD is the largest Police Department in Santa Clara County.
  - Response times are minimized.
  - Patrol officers available.
  - Special Operations Unit.
  - Community Service Officers.



# VTA Contract to Cover

- ▶ Annual Basis costs will be about 2.1 Million
- ▶ 6 FTE Police Officers 24/7 (1 per shift)
- ▶ 1 FTE Sergeant
- ▶ Supplies and Equipment



# RECOMMENDATION

Adopt a resolution authorizing the City Manager to:

- a) Negotiate and execute an agreement for Supplemental Law Enforcement Support Services with the Santa Clara Valley Transportation Authority in the amount of \$4,345,697 for the initial 2-year term (on or about July 1, 2020 to June 30, 2022),
  
- b) Exercise up to 4 one-year extensions for a total not-to-exceed amount of \$13,159,156, subject to the appropriation of funds.
