Overview of Eviction Moratorium & Council Direction

Provisions of Eviction Moratorium

- Prohibits evictions for all residential units and mobilehomes
- Includes single family homes, duplexes, condos, rent stabilized and market rate apartments

City Council Direction on 4/14

- Extend period of tenant notification to landlord
- Include language to protect against harassment and retaliation
- Include repayment period

Provide harassment and retaliation protections



Reduction in Rent Stabilization Program Per Unit Fees for Owners




