The Health Trust commends the City of San Jose's ongoing response to the COVID-19 pandemic, and recognizes the challenges of responding to an unprecedented public health and economic crisis. We know that the City must act quickly to support both public health and the economy. As a nonprofit operating foundation focused on building health equity in Silicon Valley, we also believe that emergency orders, such as the proposed requirement for fabric face coverings, should be made with a consideration of equity for our residents.

While we fully understand the important role fabric face coverings play in slowing the spread of COVID-19, we hope the City will consider equity, affordability, and accessibility before enforcing this new mandate.

We have seen how mandatory face covering enforcement across the country has been handled differently for residents based on race. In early April in Philadelphia, an African-American gentleman was forcibly removed from a public bus for not having a fabric face covering. Meanwhile, the New York Police Department released photos of officers passing out masks to white community members; however, just this past weekend an African-American mother was violently arrested for failing to have her face covering on properly.

Many community members who are at the greatest risk of severe outcomes from COVID-19 are also those being most impacted by the economic downturn. Not everyone may have the resources to purchase masks for themselves and their families.

The Health Trust respectfully requests that the City Council consider the additional cost fabric face coverings will place on our community and increase outreach and education on acceptable alternative face covering options, as well as mask reuse practices. I have not been able to recommend anything fun to our residents. None of the great restaurants, venues, events. . . and we usually have SO many!! Our downtown is extremely SAD. So empty and lifeless.

I was forced to go on leave from my job because I will not wear a mask. I have a legitimate doctors note. A lot of citizens who have difficulty breathing are too afraid to ask their doctors so they just struggle with it while grocery shopping, etc. The future of my job, which I **love** and have been doing for over 5 years, is in jeopardy because of face masks. I am 51 years old. What will I do for a job? Where will I get a job? Where will I get a job that doesn't require a face mask? Peoples faces are hot and sweaty and are breaking out. Dear Mayor and City Council Members,

On May 19, 2020, the City Council will be voting on Agenda item 3.6, 20-562, on whether to require a fabric face mask when outside one's home. We urge you to all to vote no on this agenda item.

According to the World Health Organization (the "WHO"), "there are potential risks and disadvantages that should be taken into account in any decision-making process on the use of masks", including whether "a non-medical or cloth masks could increase potential for COVID-19 to infect a person if the mask is contaminated by dirty hands and touched often, or kept on other parts of the face or head and then placed back over the mouth and nose". The WHO has explained: "Currently, there is not enough evidence for or against the use of masks (medical or other) for healthy individuals in the wider community. WHO continues to recommend that medical masks be worn by individuals who are sick or those caring for them." WHO explained, the "evidence about the benefits of these masks is limited. One good quality study showed that the risk of respiratory infection is increased (and not reduced) in health care workers using cotton cloth masks when compared to medical masks."

The WHO, has further stated, "it is possible that mask use, with unclear benefits, could create a false sense of security in the wearer, leading to diminished practice of recognized beneficial preventive measures such as physical distancing and hand hygiene." According to live science, the problem with non-medical, cloth masks is that "cloth holds on to moisture, is often reused, and filters poorly compared to medical masks." Live science indicated you need to always wear your face mask in the same orientation, and that face "masks should be machine-washed frequently to eliminate any residual flu particles, which may be contaminating the outside of the mask." It further states you must "remove your mask by taking the straps from the back of your head and pull forward — do not touch the material part of the mask. If you do, please remember to wash your hands with soap and water before and after you touch your mask." Since the failure to follow these basic protocols is common practice, as you yourselves could observe on a quick trip to a supermarket where you will regularly see dirty hands touching the material part of the mask, it is quite likely you will be doing more harm then good by requiring fabric masks with the knowledge the masks will usually be worn improperly and in a fashion more likely to increase infection than not. It is no wonder why the county health department, with one of the most restrictive shelter in place orders remaining in the state, has refused to order the wearing of such masks.

We would also suggest as a group that raises awareness about negative political implications of unjust policy on children: the negative impact of the social and emotional development of children if such masks are required in school and otherwise cannot be overlooked.

Dear San Jose City Council,

today you are discussing more restrictions on personal liberties because of the "Science." Let me just say, that the decision for this lockdown was because the state and county were afraid that the COVID 19 virus case load would overwhelm the hospitals. It didn't. According to the Santa Clara County official COVID 19 chart and analysis, there are 90 hospitalizations currently. Please note that as stated, these charts represent people who: "died in Santa Clara County with COVID19". Not because of, but with. Of the 135 reported deaths with COVID 19 in Santa Clara County, 89 percent had other underlying conditions. In other words, they likely died of the preexisting condition, not COVID 19. That means, 15 people died with COVID 19 and no preexisting comorbidity. Five percent are unknown if they died with preexisting conditions. That is 6 percent that didn't have preexisting conditions. Also the chart explains, "Deaths provided in this dashboard do not necessarily mean that the individual died of COVID 19."

This report also states that 0 surge hospital beds out of 1,231 are being used and 0 ventilators are being used for COVID 19 patients. That means there are 784 ventilators available. Santa Clara county has 2,235 hospital beds available out of 3,555 available. That's over 62 percent available.

Since last reporting there are zero new deaths and yet the San Jose City Council has decided to take a vote to require everyone to wear a mask to leave their houses. This makes zero sense. If people are afraid, they have the option to wear a mask. 135 deaths in the epicenter of a pandemic in California is a farce. In long term care facilities for residents one month ago there were 312 cases. 14 days ago in long term care facilities for residents there were 291 cases. During that period the cases only went down 21 cases. In the 14 days since that report the numbers have fallen again to 190. That's a drop of 101 cases in 14 days.

Of course the number of cases will rise as you test more people. That number is irrelevant. The fact that there are no new deaths and only a total of 135 COVID 19 suspected deaths should tell you to end the lockdown. It just isn't as deadly as everyone thinks. Let's admit our mistake and move on.

Thank you for inviting public comment regarding your consideration of a new order that would require people to wear face masks, effectively at all times while outside of their homes. These orders are foolish and harmful.

Initially, we were told that we needed to stay at home and practice "social distancing" for two weeks, in order to "flatten the curve," because the hospitals would be overwhelmed if we didn't, and we needed to help avoid a crisis of insufficient hospital capacity, supplies and staff. That narrative turned out to be wildly false. The hospitals never were overwhelmed. Many of them are relatively very empty, and across our country, we're even now experiencing cases of medical staff being furloughed or laid off. Even worse, the political narrative has now changed. Now we are being told that we need to continue social distancing and wearing face masks and continue restrictions on so called "non-essential" businesses, to "contain" the virus until we have a vaccine. This defies science, as well as common sense. Nobody can contain a virus. That is an impossible goal. And the goal of waiting for a vaccine reveals the self-interest motive of financial gain and power grab of the CDC, WHO, big pharma, and others who are invested in the vaccine industry, which garners \$60 billion in annual revenues.

What government officials actually should be doing, if they care about the well being of their citizens, is encouraging the development of herd immunity, while offering assistance to the most vulnerable of the population. It is a well documented fact that COVID-19 poses a serious threat to the very elderly and very sickly but almost no risk at all to approximately 99% of the population. The actual fatality rate of COVID-19, calculated as number of deaths *caused by* COVID-19, divided by the number of people *who have* COVID-19 (including the many with no symptoms) probably is between 0.1% and 0.3% - *approximately 20 to 30 times lower than the initial estimates propagated by the WHO!* And the deaths are highly concentrated in the segments of the population older than 80 years old and those with preexisting, life threatening health problems. Therefore, what should be happening is that the general population should be going about their regular activities - going to work, going to school, going to church, going to social gatherings, going to the gym, eating in restaurants, and so on - to develop herd immunity. Once 70% to 80% of the population has been exposed to the virus, widespread immunity will be developed naturally, and the virus will be extinguished. This sort of thing happens every year during cold and flu season. It's no secret. Meanwhile, government agencies should offer - but not mandate - assistance to the truly vulnerable in our society - the very elderly and the very sickly.

You don't have to take my word on this. You can look to the testimony from some of the world's top epidemiologists and medical professors: Drs. Ioannidis, Bendavid and Bhattacharya, of Stanford University; Dr. Wodarg, of the University of Hamburg; and Dr. Wittkowski of the University of Stuttgart and the University of Tuebingen; as well as many other medical doctors and epidemiologists, around the world, who have not been

shy about calling the shelter-in-place and social distancing policies a "fiasco" and saying that these policies are ordering exactly the opposite of what should be happening. (But these expert voices have been shunned and even silenced, as we are repeatedly ordered to just obey political orders that defy common sense, as well as science.) Moreover, if you study countries that did not shut down business and did not enforce social distancing - countries like Japan and Sweden - you will find that they have fared just as well or better than many other countries with strict lockdowns.

Finally, you should seriously reckon with the fact that the very harmful orders of governors and county health officers around the country have caused much greater harm to many millions of people than the virus ever will. Many small business owners have lost their businesses. At last count, 35 million Americans have lost their jobs. Approximately half of all households in the country that had annual income of \$40,000 or less have lost their income. The United Nations is now predicting a global crisis of starvation. How ironic this is, since an arm of that organization, in large measure, caused this crisis.

I urge the San Jose City Council to shine a light in the darkness that has overtaken our state, our nation and our world. Reject the insanity that has infected the minds of politicians throughout our state, country and Western Civilization. Reject the foolish orders of California Governor Gavin Newsom. Reject the foolish orders of Santa Clara County Health Officer Sara Cody.

Justice will come to the government officials who have harmed millions upon millions upon million of vulnerable people by their foolish orders. Many times, justice appears to be slow moving to us mere mortals. But it will come, whether in this life, or the next, or perhaps both. As Martin Luther King, Jr. said, "The moral arc of the universe bends toward justice."

Reject the foolish idea of ordering face masks to be worn. Face masks on the general population accomplish nothing, except to cause people to touch their faces more often, which tends to spread viruses and bacteria more pervasively.



As a mother and a San Jose resident, I strongly urge you to vote NO on the order for everyone to wear masks outside of their houses. I have no doubt you are aware of many reasons for voting no - but I'm going to let you know of my personal reason, that might also affect someone you know; my daughter is deaf.

I worry about the minority that often gets ignored. Many hard of hearing individuals use lip reading as a main form of communication. I have heard from multiple people in the community that they are feeling discriminated against. Store employees are brushing them off, not taking the time to even write conversations down. The ability to be heard, and to understand others, is greatly impaired by using masks.
