 3.3 19-401 Mayor's Gang Prevention Task Force Audit Report. As recommended by the Public Safety, Finance and Strategic Support Committee on May 16, 2019, accept the Mayor's Gang Prevention Task Force Audit. CEQA: Not a Project, File No. PP17-009, Staff Reports, Assessments, Annual Reports, and Informational Memos that involve no approvals of any City action. (City Auditor) [Public Safety, Finance and Strategic Support Committee referral 5/16/19 - Item (d)4]

Interim City Auditor Joe Rois provided the report, and Director of Parks, Recreation and Neighborhood Services, John Cicirelli offered a response. Council discussion followed.

<u>Public Comments</u>: Twelve members of the public attested to the program's success and appealed to Council for continued resources.

<u>Motion</u>: Councilmember Sylvia Arenas moved approval of the memorandum she coauthored with Vice Mayor Chappie Jones, dated May 31, 2019, also including the joint memorandum from Councilmember Sergio Jimenez and Councilmember Magdalena Carrasco, dated June 4, 2019, with amendments as noted in "Action". Vice Mayor Chappie Jones seconded the motion.

Mayor Sam Liccardo requested a friendly amendment to include clarification that gang activity will remain a subset of crime reports under youth violence and youth crime. The friendly amendment was accepted.

<u>Action</u>: On a call for the question, the Mayor's Gang Prevention Task Force Audit Report was accepted, including the memorandum from Councilmember Sylvia Arenas and Vice Mayor Chappie Jones, dated May 31, 2019, to:

Accept the Audit on the Mayor's Gang Prevention Task Force and Administration Response, and direct the City Manager to:

1. Implement an interim solution for school service delivery site misalignment, as an additional step for Recommendation 9, in time for the upcoming 2019-2020 school year. a. Utilize the data assembled by the City Auditor, with a focus on alignment with Level 1 and 2 incidents.

b. Where school-city coordination has presented a challenge to effective alignment at school sites, work with Council offices and/or City Administration to help find solutions to service delivery challenges.

2. Incorporate a December 2019 report in the PSFSS workplan with updates on:

a. Implementation of audit components, especially those with December 2019 timelines

b. Formalize the Police Department role of providing violent crime data and gang-related crime data (by MGPTF Hot-spots and Emerging Hot Spots) as part of the Bi-monthly report to PSFSS, as an annual presentation, and sharing this data each

year with the MGPTF Technical Team and Policy Team.

c. Direct staff to review and report out on the feasibility of segmenting future grants by target population profile to ensure that each segment has sufficient targeted services provided.

d. Discussion of Mayor's Gang Prevention Task Force name change as mentioned in previous Policy Team and PSFSS meetings.

3. Reaffirm the funding commitment to MGPTF, and encourage PRNS to seek further funding when available. If the City establishes an Equity Fund, seek funding from that fund. 4. Add risk factors to the MGPTF Target Population Profiles "At-Risk" and "High-Risk" that would include exposure to sexual assault, domestic violence and family violence as "gang risk" characteristics.

(a) Accept the report from Intergovernmental Relations and reaffirm all City positions summarized in the Intergovernmental Relations Priority Legislation Log.
(b) Approve the Intergovernmental Relations Program 2.0 action items. CEQA: Not a Project, File No. PP17-010, City Organizational & Administrative Activities resulting in no changes to the physical environment. (City Manager)

Director of Intergovernmental Relations, Bena Chang, opened this discussion, offered clarification and responded to questions. Council discussion ensued.

<u>Action</u>: Upon motion by Councilmember Johnny Khamis, seconded by Vice Mayor Chappie Jones and carried unanimously, the Staff recommendations were approved including support of a more accountable decision-making process regarding the shutdown of electricity transmission lines instead of allowing PG&E to solely make those decisions without a decision-making body, and who will look at the health and safety of the community in total; and including the memorandum from Mayor Sam Liccardo, dated May 31, 2019, to "Clarify the City's position on Elections Code Section 13119/AB 195 to advocate for reform—and not the elimination—of disclosure provisions that subject local governments to unnecessary and unwarranted litigation for the passage of bond measures." (9-0-2. Absent: Carrasco, Esparza.)

### 3.5 19-423 Potential 2020 Ballot Measures - Affordable Housing and Homelessness.

(a) Accept the staff report on potential 2020 ballot measures that could help provide affordable housing and address homelessness.
(b) Direct the City Manager to conduct additional survey research regarding potential 2020 ballot measures and to return to Council in August 2019 with an update.
CEQA: Not a Project, File No. PP17-010, City Organizational & Administrative Activities resulting in no changes to the physical environment. (Housing/City Manager)

A presentation was provided by Chief of Staff, Office of the City Manager, Lee Wilcox, Director of Housing Jacky Morales-Ferrand and Assistant to City Manager, Michele McGurk.

<u>Public Comment</u>: Nine members of the public expressed concerns and opinions regarding potential 2020 ballot measures.

<u>Motion</u>: Councilmember Johnny Khamis moved his memorandum dated May 31, 2019. Councilmember Sergio Jimenez seconded the motion.

Mayor Sam Liccardo asked for clarification regarding the motion, with Councilmember Johnny Khamis expressing his opinion that the City should not be studying further taxation at this time.

<u>Substitute Motion</u>: Councilmember Sylvia Arenas moved approval of the staff recommendations, including exploration of a commercial-only property tax and a vacancy tax. The motion was seconded by Councilmember Magdalena Carrasco.

# Council recessed at 5:30 p.m., returning at 6:20 p.m. with all Council members, with the exception of Councilmember Maya Esparza, present.

<u>Action</u>: On a call for the question, the substitute motion carried, with Staffs' recommendations accepted, including exploration of a commercial-only property tax and a vacancy tax. (7-3-1. Noes: Davis, Foley, Khamis. Absent: Esparza.)

### 4. COMMUNITY & ECONOMIC DEVELOPMENT

### 6.2 19-408 Rail Corridor Plan for San José and Inter-Agency Agreement. Direct the City Manager to develop an agreement between the City of San José, the Peninsula Corridor Joint Powers Board, the Santa Clara Valley Transportation Authority, and the California High-Speed Rail Authority that will provide for development of a Rail Corridor Plan for San José. CEQA: Not a Project, File No. PP17-007, Preliminary direction to staff and eventual action requires approval from decision-making body. Council Districts 2, 3, 4, 6, 7, & 10. (Transportation)

<u>Motion</u>: Councilmember Dev Davis moved approval of the staff recommendation, including the May 31, 2019 memorandum she coauthored with Mayor Sam Liccardo and Councilmembers Jimenez, Peralez and Esparza.

<u>Action</u>: On a call for the question, the staff recommendations regarding the including the San José Diridon Integrated Station Concept Plan and Rail Corridor Plan for San José and Inter-Agency Agreement were accepted, including the joint memorandum from Mayor Sam Liccardo and Councilmembers Jimenez, Peralez, Davis and Esparza, dated May 31, 2019, to: Accept the staff memo with the following recommendations:

1. City staff to work with VTA, Caltrain, and High Speed Rail on an agreed-upon scope of work and preliminary funding plan for the interagency agreement, and Rail Corridor Plan, to be brought to Council prior to the High Speed Rail Authority Board meeting in September where they will be considering the Preferred Alternative for the San Jose to Merced segment.

2. Prior to publishing the Draft Environmental Impact Statement/Report (EIR/S) for the San Jose to Merced segment - staff should return to Council with an interagency agreement that allows for multi-agency collaboration, accounts for the need to integrate multiple overlapping plans and projects - and ultimately delivers high-quality rail service in San José.

Establish which local agency would constitute the lead agency for the EIR, and commence scoping for the study.

(c) Authorizing the Director of Community Energy or her designee to negotiate and execute medium- to long-term contracts using the Edison Electric Institute Agreement or the Western Systems Power Pool Agreement with modifications, as appropriate, in consultation with the City Attorney, for a term of up to twenty years to procure Resource Adequacy products from different technologies, including battery storage, in an amount not to exceed \$451,800,000 in aggregate over twenty years, subject to the Energy Risk Management Policy, Risk Oversight Committee approval, and the appropriation of funds. CEQA: Not a Project, File No. PP17-003, Agreements/Contracts (New or Amended) resulting in no physical changes to the environment. (Community Energy)

Director, Community Energy Department, Lori Mitchell offered a presentation.

<u>Action</u>: Upon motion by Councilmember Johnny Khamis, seconded by Councilmember Dev Davis and carried unanimously, **Resolution No. 79109**, related to Actions Related to the 2019 and 2020 Power Supply Procurement and contracts, was adopted. (10-0-1. Absent: Esparza.)
