## **COUNCIL DISTRICT: 2**

## **RECOMMENDATION**

Adopt "Golden Oak Park" as the name of a future park, located on the east side of Via del Oro approximately 300 feet north of Raleigh Road.

#### **OUTCOME**

Approval of the recommendation would guide the Department of Parks, Recreation and Neighborhood Services to record the site as Golden Oak Park in its parks' inventory, and design and install a park name sign along Via del Oro as part of future park development (Attachment A – Location Map).

### **BACKGROUND**

The City will acquire an approximately 1.5-acre fully developed park site from the iStar development project (formerly Tree of Life). Construction documents are being prepared and start of construction is anticipated this fiscal year. This neighborhood-serving park will feature several amenities including, a play lawn, playgrounds, exercise equipment, and a new oak tree planted in the center of the park per the Master Plan. A Master Plan was prepared with community input and approved by the City Council on February 28, 2017.

Staff solicited recommendations from the community on park names and conducted a poll to determine those most favored. In total, staff saw good community engagement with over 500 responses. Staff recommended the name "Urban Oak Park" to the Parks and Recreation Commission (PRC) during a public meeting on March 4, 2020. The Commission made an alternate recommendation and approved "Golden Oak Park" as its intended recommendation to Council.

#### ANALYSIS

City Council Policy Number 7-5, Naming of City-Owned Land and Facilities, establishes guidelines and procedures regarding the naming of City-owned land and facilities that are not public streets. Per the Policy, the City requires names be reflective of one of the following criteria:

- A. Geographic location;
- B. Prominent geographic feature or local reference point;
- C. Adjoining subdivision/community;
- D. Historical event;
- E. An individual who has been decease for at least five years;
- F. An individual via a donation or sponsorship agreement; and
- G. A group via a donation or sponsorship agreement.

As a result of community polling, staff proposed the name Urban Oak Park because it aligned with local references to the oak trees that previously dominated the landscape in the area. Use of the adjective Urban was deemed appropriate as it conveyed the changing land uses in the area with high-density housing, employment and resources.

At its meeting of March 4, 2020, PRC recommended "Golden Oak Park." This name conforms with the City Council policy, in that it reflects the history of the neighborhood and a local reference point in the area. The name was supported by the public during the naming process and secured the second most votes. The name acknowledges the oak trees were once prominent in the area, which will be acknowledged by the planting of a new oak tree in the center of the park. The name also aligns with the geographic area, as the park is along the adjacent street "Via del Oro" which is Spanish for "Golden Way" or "Way of Gold."

PRC has the authority to consider public input while making its preferred recommendations to the City Council. Because no strong arguments or correlation to person, place or event was made, the change in name is supported by staff.

#### **CONCLUSION**

The park naming process follows City policy to develop suitable park names that reflect a broad range of criteria. The naming process is also based upon preference when more than one name is available. The PRC's recommendation for Golden Oak Park is consistent with Council Policy, reflects a preference for a name that aligns with the local landscape and references a local roadway, and was supported by the community as the second most favored name.

#### **EVALUATION AND FOLLOW-UP**

If the Council adopts this name, staff will coordinate with the City Clerk's Office and the Public Works Department Community Facilities and Architectural Services division to ensure that the name "Golden Oak Park" is recorded and included on park signage.

#### **CLIMATE SMART SAN JOSÉ**

The recommendation in this memo has no effect on Climate Smart San José energy, water, or mobility goals.

#### **PUBLIC OUTREACH**

Staff completed a series of three online park naming survey processes to encourage public participation, to solicit name nominations, and to allow the public an opportunity to vote on qualifying names. The survey period was from July 12, 2019 to January 17, 2020.

Staff received 505 responses, with 18 qualifying names that met policy requirements being identified. Participants voted for favored names as follows; Urban Oak Park (89 votes), Golden Oak Park (56 votes), Lone Oak Park (47 votes), and Keesling Park (45 votes).

A list of all nominations and the number of votes each received is provided in Attachment B List of Nominated Names. The Nomination Form for the Naming of City-Owned Facilities is available in Attachment C.

#### **COORDINATION**

This memo was coordinated with the City Manager's Budget Office and the City Attorney's Office.

#### **COMMISSION RECOMMENDATION/INPUT**

On March 4, 2020, the Park and Recreation Commission conducted a public hearing to consider the staff recommendation "Urban Oak Park" as the naming of the new park. During the discussion Commissioners voiced concern that the recommendation is a misnomer, as the prominence of oak trees in the area have been greatly diminished by new development. Further, Commissioners suggested that the word "urban" invokes a mental image that is not reflective of the character of neighborhood. Commissioners also expressed concern that the name is the same as the development under construction and were worried that it would cause confusion among community, giving the impression that it is private park. Commissioners reviewed the list of qualifying names (Attachment B: List of Nominated Names) that was provided with the staff report and discussed two alternative options: Big Blue Park and Golden Oak Park.

Big Blue Park was suggested to commemorate the surrounding technology campuses and IBM's former presence on the site (IBM has often been informally referred to as "Big Blue"). No major objections to "Big Blue" were discussed, though it was acknowledged that the nearby RAMAC Park also commemorates the technology district and history in the area. Alternatively, "Golden Oak Park" was suggested because it reflects the community's desire to acknowledge the oak trees, reference to a local roadway, received support from the community, and the term "golden" elicited positive connotations.

A motion to nominate "Golden Oak Park" as the name for this facility was put forth and seconded. Six commissioners voted in favor of this name and one commissioner voted against, and three were absent (6-1-3).



#### Attachment B – List of Name Nominations

The justifications for name submissions provided by survey participants are unedited by staff. Fact checking for participant submissions only occurred for nominated names presented to the public for voting and considered by staff for recommendation to the Parks and Recreation Commission. The names presented to the public for voting in the surveys are identified with an asterisk.

Nomination	Justification Provided	Policy Conformance
*Urban Oak Park (89 votes)	Highlights San José's urban character, the historical character of the area, and the new oak tree that will be featured in the center of the park (staff nomination).	Conforming; Prominent geographic or local reference point; Adjoining subdivision/community.
*Virginia Shaffer Park (11 votes)	Commemorates San José's first female Council Member (staff nomination).	Conforming; Deceased individual.
*Via Del Oro Park (34 votes)	Translates to "The way of Gold." Celebrates San José's gold rush history and is the name of the adjacent street (staff nomination).	Conforming; Prominent geographic or local reference point; Adjoining subdivision/community.
*Lone Oak Park (47 votes)	It highlights the effort that the city and 300 years of property owners made to save this giant specimen all by itself in the coyote creek plains.	Conforming; Prominent geographic or local reference point; Adjoining subdivision/community.
*Golden Oak Park (56 votes)	Reflects the history of the trees there (and in San José) as well as an optimistic thought about a future in this area or a safe and serene place to rest "golden".	Conforming; Prominent geographic or local reference point; Adjoining subdivision/community.
*Tree of Life (41 votes)	The "Tree of Life" name is derived from the theme proposed by San José PRNS of Biomimicry. The submitted design is themed around a central specimen oak tree and focuses on the regional ecology associated with mature trees. The name also recognizes and is derive from the surrounding development and street name of "Great Oaks" (developer recommendation).	Conforming; Prominent geographic or local reference point; Adjoining subdivision/community.
*Monarch Park (38 votes)	It will bring attention to the plight of the Monarch Butterfly and with proper planning, can incorporate milkweed and become a park for these beautiful butterflies as well as for the residents of this area.	Conforming; Prominent geographic or local reference point.
*Big Blue Park (42 votes)	It was IBM (Big Blue), which was instrumental in nurturing and developing South San José Area and ushering new area of technology to the Silicon Valley.	Conforming; Prominent geographic or local reference point; Historical event.
*Keesling Park (45 votes)	Pays tribute to Horace Keesling, who planted walnut trees from San Jose to Gilroy in the 1900s, most of which still stand today. Because it has to do with the tree's that were planted here. To help the environment and grow and beautify the area.	Conforming; Deceased individual.
*Rosalind Franklin Park (27 votes)	Rosalind Elsie Franklin was an English chemist and X-ray crystallographer who made contributions to the understanding of the molecular structures of DNA, RNA, viruses, coal, and graphite. These were important discoveries on a global scale, and DNA is the center of the genetics industry today. All people should be proud to have a park named for something as notable as these discoveries.	Conforming; Deceased individual.

Progressive Park	Because IBM is all about being progressive in thinking, leadership, policy and action.	Conforming; Prominent geographic or local reference point; Historical event.
Great Oaks Park	Maybe a geographic name would be better, such as Great Oaks Park, but I'm not sure just how close this is to Great Oaks Blvd and I can't find the location on a map from the names giventhey appear to be from a very different area of San José.
