Respected Sir,

I am a resident and tax-paying homeowner of a single-family home in 95138.

We want to help rehabilitate the homeless. We support using part of our taxpayer dollars to achieve that and laud the efforts of our elected officials towards that goal. But we cannot accept increased crime, drug use, disturbance, and disorder near our homes[1] and children's schools[2]. Homeless shelters have those effects on a neighborhood. It is unfortunate but it is true [3].

I hereby request you that please don't make a homeless shelter within 5 miles of residential neighborhoods and schools. Let us help the homeless in another way; a way that does not threaten our safety, bring drugs to our children's schools, and erode our property values.

Apart from this, I would also like to bring your attention to a few other concerns.

- 1) There are many other options like hotel rooms, fairgrounds, stadiums, convention centers, etc to provide temporary housing during the COVID crisis.
- 2) These locations are far from transit and support services.
- 3) There is no evidence that this approach will be successful in solving homelessness e.g. it cannot house the thousands of homeless people we have.
- 4) The costs are really high and this is a waste of taxpayer money.
- 5) Special interests (like Google development in Downtown) are trying to shove this problem down the throats of D2 residents that will have to suffer the long term negative consequences.

I hereby request you to kindly review your options and completely eliminate the Monterey Bernal site from your list for future BHC sites.

Dear community of San Jose, and city govt,

Please make this an official letter, of public inquiry & protest, for the tree removal project, in the Post Street alleyway, in downtown San Jose.

Choose 1 of 3 sections, at a sitting, for quicker reading.

I talked with both, Nara Baker and Kaitlin Shelton, of the City arborist. Friday May 15, 2020.

They very nicely described, the sjda/sj city govt project, of all the trees to be removed, and replaced, in the Post Street alley way, in downtown sj.

It is between, 1st & Market, and Santa Clara st. & San Fernando st.

I have been told, this is an sj downtown association, sjda, decision making process. As they are in charge, of maintenance issues for downtown.

The SJDA has paid for, an arborist report. And that these trees, have had years, of maintenance, disease, and replanting issues.

They want to replace, the current Chinese pear trees, in the Rosacea family, with a combination, of maple trees, and forest pansy redbud trees.

Deciduous trees, with many colors, in the fall.

Brittle branches falling, the age of the trees, and the disease, fire blight, are some of the issues, of the aged pear trees.

To clean up, the leaves of fall - will also be an issue, for the new trees.

The SJDA & city govt, want to do this, all at once.

And not use, a phased-in system.

As Nora Baker, sj city arborist felt, this can provide, better maintenance, continuity, and save costs, when planting the new trees, all at once.

Interestingly, as city trees, are usually planted, in their third and fourth year, the SJDA is trying to select trees, that are little larger, and in their 6th & 7th years of life.

As the shade and ambiance issues of the trees, in the Post Street alleyway, should be an important issue, for everyone.

I do not know the depth, of how to talk about tree care.

Or how to practice, good advocacy.

It may be past time, to advocate, to keep the original trees, that are already past, their normal, 25 yr lifespan, and are somewhat high maintenance.

Among other things, I have also learned, the fire blight disease, can be stressful, for the trees.

So overall, I will still advocate, to keep the trees as they are. But it seems important, to begin to try to ask -

Can a phase-in plan, be more sensitive, and offer a softer approach, compared with, replacing the trees, all at once.

And to not be, a shock, to the collective human consciousness, of downtown San Jose.

Nara Baker, city govt arborist, and liaison, to this project, has stated, it would be, with some loss of care & convenience, and a slight raise of budget dollars, to opt for, the phase-in plan.

I guess, it would take some effort, to adjust & create, a few, new maintenance ideas, with a phased-in system.

But in years, of attending sj city council meetings, I've come to learn, with a bit of haggling, there can be decent ways, to make adjustments.

And to continue ideas, of TLC needed, for the new trees.

With perhaps, only slightly higher budget costs, each year, only in the thousands of dollars.

This is supposed to be, one of the last days, to offer a formal public protest.

They are supposed to be, cutting down, and replacing the trees, in the next few weeks, or within the month.

So we have to work, a bit quickly, at this time, and thoughts, "on the front burner," toward a phase-in plan, for the trees, at this time.

Even as you have probably, already talked this over, with many of the downtown area - I hope this letter, can be a good check up,, ask around, and open review time, with each other.

And what can be, the best way to proceed, with tree replacement, for the Post St. alley.

With Covid-19 orders, this will be a shock to the system, for everyday people, not in the know.

Can someone write back, both the positive, and the negative, of how local downtown merchants, feel about the situation.

Groups like, the San Jose downtown jazz festival people, among others.

In my conversations Friday, with city govt. arborists, I do not doubt, their care, and how to work on this issue.

And a phase-in plan, compared to, an all at once plan, to replace all of the current trees, in the Post Street alleyway,

An all at once plan, has established ways, and saves a bit of money.

I feel a phase-in plan, can create, its own care & convenience methods, of TLC, and is friendlier, more sensitive, to everyday community.

I hope, both these ideas, can be thought out. And we can have, good mutual agreements, whatever can be decided.

Thank you, for your time. Please write back.

I hope, we can work on this issue, in conversational good terms, now. And in however, it can work out.

As there may only be, a month or less, before the trees are scheduled, to be cut down.
