RECOMMENDATION

- 1. Approve recognition of Philippine Independence Day on Friday, June 12, 2020 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the Tuesday, June 9, 2020 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Philippine Independence Day will be recognized on Friday, June 12, 2020 and sponsored by Councilmember Arenas. This special event recognizes June 12, 2020 as the 122nd anniversary of Philippine Independence Day in lieu of a flag raising at City Hall to celebrate and commemorate the thousands of Filipino and Filipino-American community members that have contributed to the City of San Jose. The 122nd anniversary of Philippine Independence Day aims to recognize and honor the contributions of Filipino and Filipina healthcare workers and nurses to serve and protect the health and well-being of our community amidst the current global pandemic.
