**WHEREAS,** the Council of the City of San José supports the development of a local equity program; and

**WHEREAS**, the Council of the City of San José has determined that it will use grant funds in the amount of \$149,300.37 from the Governor's Office of Business and Economic Development to conduct a cannabis equity assessment and/or assist the development of a local equity program; and

WHEREAS, the City Manager, or their designee, executed a grant agreement with the State of California's Governor's Office of Business and Economic Development for the
