Specifically, on a post where members of the public were expressing their outrage over Diep's support of the continued employment status of Officer Jared Yuen. If this is still true, I want to say that I am appalled at Lan Diep's mindset in turning a deaf ear to the constituency that elected him. I voted for him once. But, that will be the last vote that he gets from me. Lan Diep needs to be aware that he lives in a democracy – not in a dictatorship. In the United States, elected officials do not have the power to silence the voices saying things that they don't want to hear.

Chief Eddie Garcia was quoted as referring to Officer Yuen as a 'kid' and that his emotions got the better of him. Officer Yuen is a 6-year tenured officer – not a kid. He is also very well paid. As such, he should be held to the professional standards of SJPd and the City of San Jose and face real-world consequences for his behavior on the job. Even though the City Council does not directly hire and fire police officers, I urge you to take action to terminate Officer Jared Yuen (SJPd Badge Number 4362). My name is Destiny Martinez and I am a resident of San Jose. I am emailing today to demand accountability for the excessive violence displayed by the San Jose police officer Jared Yuen (badge #4362).

I demand that Jared Yuen be fired for displaying a gross abuse of power and endangering the lives of unarmed citizens. I understand that an investigation is being done, but video evidence showing his blatant disregard for the safety of the public is apparent.
