BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Shop Local Spotlight began on Thursday, May 28, 2020 and will go through the month of June 2020 as a virtual event and sponsored by Councilmember Arenas. This special event is an online initiative aimed to promote and support local restaurants throughout District 8, featuring weekly Facebook posts spotlighting District 8 businesses. The event is free and open to those who want to participate in a drawing to support local restaurants.

T-shirts and \$25.00 gift cards to participating restaurants were purchased by Council District 8, which were included in gift baskets dedicated towards the prize drawing for constituent appreciation for supporting local restaurants. The prize drawing was free and open to the public.
