Good morning,

My name is Jon Telebrico and I have been a student of San Jose the past four years. I am writing today because I am concerned about the way that this community—especially the black and brown citizens within it—have been treated with regards to the police department.

Back in 2014, the San Jose Police Department returned a mine-resistant armored vehicle, citing concerns of maintaining community trust. California is one of the biggest beneficiaries of the federal 1033 program, and today you have a real opportunity to help create change when it comes to the way police use force and various other "crowd control" measures.

Residents of this city should not have to fear for their lives because they see military grade weaponry rolling down the same streets that they walk and live on daily. We should not be forced to witness a lack of transparency on the part of SJPd, especially given recent events such as the treatment of peaceful protestors by the violent and antagonistic actions of officers like Officer Jared Yuen.

There ought to be standards of accountability when it comes to the use of force against those who are exercising their constitutional rights to assemble. This includes:

- 1) Demilitarizing the force and the use of high grade weaponry acquired through programs like the aforementioned 1033 program, thereby committing to return much of these unnecessarily violent weapons
- 2) The increased use of body cameras and other forms that hold the police accountable to the public whom they are serving
- 3) Clear and outlined protocols which disallow officers from inciting violence during relatively peaceful protests, and discontinuing the practice of arresting said protestors on vague grounds

These are just a number of things that you have the power to commit to today. As an extremely diverse city inhabited by thousands of people of color, San José ought to take charge and implement these measures rather than empowering racist and violent institutions.

Realize that the conversation cannot simply end here—there must be continued discussion with regards to how the increased money to the SJPd in the proposed budget diverts funds from things like traffic safety and street improvement, library hours, community service officers, parks maintenance, and other important programs. Investing in our police force while divesting from low-income communities within San Jose is extremely detrimental to citizens. If we want to combat systemic and institutional racism, we have to address the inequalities entrenched in infrastructure, education, and ecology that disproportionately affect communities of color, especially black communities. Please keep these concerns in mind going forward.

Hello,

My name is a Celeste Afanador and I am asking you to please take the 8CantWait Pledge and execute these demands. My name is Farrah Schiff, and I am a resident of San Jose (as well as a county employee and proud union member). While the city seeks to understandably make cuts to address the COVID-19 deficit, I am writing to demand that funding is instead reallocated from SJPd (and the golf courses) to social and public programming for our communities (education, affordable housing and housing support for the homeless, healthcare and mental health services, social services, libraries, parks, and public transportation). The current system is not about protecting *\*all\** citizens—and must be reimagined.

I support fully the calls that the San Jose City Council defund the SJPd and invest their budget into the services mentioned above. The city budget should support community well-being, not about “saving” the police through superficial reforms (including xpanding the budget to include more accountability technology and training). The city must, also, make the details of police union contract negotiations public.

*\*IN THE MEANTIME\**, the use of rubber bullets, tear gas, and other means of excessive force as methods of crowd control must be banned. The city must recognize and support the First Amendment rights of the protestors, and not fund police violence against them.

The policy proposed recently by the SJPd limiting the use of projectile impact weapons, like the one used against Derrick Sanderlin, is already included in the SJPd Duty Manual. Section L 2629, adopted in 2018, already prohibits these weapons unless there are one of two specific conditions: (1) a suspect is armed and likely to commit harm or (2) the use of these weapons is likely to prevent serious injury. Neither of these descriptions describe Derrick during the protest. Either the officers involved were not properly trained or willfully neglected their training in the duty manual. What consequences are you currently pursuing against the officer or officers involved in Derrick's attack? And how are you planning to address other officers who act outside of the duty manual in this way? We already know this policy - the one recently proposed and the one already on the books - does not prevent officers from attacking protesters with unreasonable force.
