WHEREAS, Section 15.12.550 of the San José Municipal Code requires the Director of Finance to file a report each year with the City Clerk, on or before July 5, or such other date or dates as the City Council may specify by resolution, regarding Sanitary Sewer Service and Use Charges ("SSSUC"), and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of annual SSSUC, and the time and place of the public hearing; and

WHEREAS, Section 15.16.1410 of the San José Municipal Code requires the Director of Finance to file a report each year with the City Clerk, at least fifteen (15) days before the public hearing on the Storm Sewer Service Charge ("SSSC") assessments, and requires the City Clerk to cause notice of filing of the report issued by the Director of Finance regarding the imposition of annual SSSC, and the time and place of the public hearing; and

WHEREAS, City staff recommends that the filing date for the Director of Finance's annual report for Fiscal Year 2020-2021 SSSUC be moved from July 5, 2020 to July 15, 2020 in order to allow staff the time necessary to provide the most complete, accurate and current listing of the Fiscal Year 2020-2021 SSSUC and SSSC;
